**A RESOLUTION AMENDING RESOLUTION 2019-27,
A RESOLUTION SELECTING A COMMUNITY DEVELOPMENT BLOCK
GRANT (CDBG) INFRASTRUCTURE PROJECT;
AUTHORIZING THE SUBMISSION OF A NEW MEXICO CDBG PROGRAM
APPLICATION TO THE DEPARTMENT OF FINANCE AND
ADMINISTRATION/LOCAL GOVERNMENT DIVISION/COMMUNITY
DEVELOPMENT BUREAU FOR THE PROJECT; AND
AUTHORIZING THE COUNTY MANAGER TO ACT AS THE CHIEF
EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL
MATTERS PERTAINING TO THE APPLICATION AND SANTA FE
COUNTY'S PARTICIPATION IN THE CDBG PROGRAM**

WHEREAS, on February 26, 2019, the Board of County Commissioners ("Board") of Santa Fe County ("County") adopted Resolution 2019-27, selecting the Project identified therein;

WHEREAS, on June 20, 2019, the County submitted a CDBG application for the Project ("Application") to the New Mexico Department of Finance and Administration/Local Government Division/Community Development Bureau ("DFA");

WHEREAS, on June 20, 2019, DFA advised the County that the Application must include a phased project request amount.

NOW, THEREFORE, BE IT RESOLVED by the Board that Resolution 2019-27 is amended to add the following statements:

6. The Application shall request a phased project request amount of \$300,000.00.
7. The Board commits to provide \$30,000.00 as a cash contribution toward the phased project.

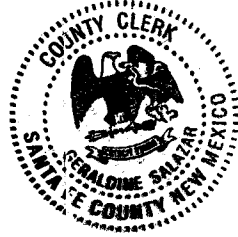
