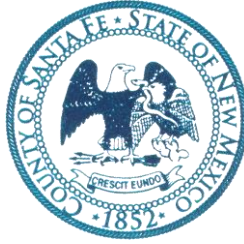

- Santa Fe County Public Works Department is requesting bids from qualified and licensed contractors for construction services for the Arroyo Hondo Trail located in Santa Fe County funded by the Federal Highway Administration (FHWA). The work consists of the construction of a 1.52 mile long concrete multi-use trail connecting the exiting Rancho Viejo Fire Station Trailhead to the existing La Pradera Trail, and to the existing trail at the I-25 / NM 14 Interchange in Santa Fe County.
- Liquidated Damages: \$2000 per each working day that expires after the date of substantial completion until substantial completion is achieved and a certificate of Substantial Completion is issued by the County.

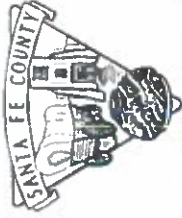
