The types of cards (corporate, business, p-cards, consumer), types of rewards, PIN debit vs signature debit, how the transaction is processed (card present vs non-card present), EMV chip inserted or not, interchange optimized or not and level 2 data entered or not, all have a bearing on how much the county pays. The County does not receive statements from credit card services. We did provide a 6-month activity of merchant services in Addendum No. 1.
