Dear Proponents,

This addendum is issued to reflect the following immediately. It shall be the responsibility of interested Offerors to adhere to any changes or revisions to the RFP as identified in all Addenda. This documentation shall become permanent and made part of the departmental files.

PLEASE SEE ATTACHED SIGN-IN SHEET FROM PHASE I-SHORTLIST PRE-PROPOSAL MEETING, HELD MAY 7, 2018.

The following questions have been received regarding RFP No. 2018-0350-CMO/BT, with corresponding answers:

Q-1 Is the project subject to LEED Certification under NM State Executive Order 2006-001?

A-1 **No. The County is not subject to the referenced State Executive Order. The bridging documents that will be provided to the shortlisted D-B Team during Phase II evaluation process will include the performance standards that will be required for the D-B Team to meet in their respective design solution and cost proposal.**

Q-2 **If the construction Contractor is from outside the County or State, but their Architect of Record is within the County and has a County Local Preference Certificate, will the Proposal receive the 5% preference?**

A-2 Yes, but only for the Phase I – Shortlisting evaluation.

Q-3 **Do the points from the Shortlist evaluation carry over to the Phase II evaluation?**

A-3 The total points from the shortlist evaluation *will not* carry over to Phase II evaluation. The only points that may carry over from the Shortlist evaluation are the points the Offeror receives for Project Staffing and Past Performance, *unless* the Offeror indicates that conditions changed from their initial Phase I response.

- Q-4 If the Offeror uses attachments for resumes, etc. in response to Past Performance, will the attachments count against the page limit of the proposal?**
- A-4 No. But caution must be given to Proponents to the RFP that the use of attachments as a response to the criteria factors, will effect the evaluation committee ranking. Attachments should only be used for what would be considered as supporting documentation.
- Q-5 Please confirm project completion date. Page 6 says March 2020 and Page 24 states December 2019**
- A-5 The completion date for the construction of the new building is December 2019. The completion date for the entire project, including renovation of the existing building is March 2020.
- Q-6 Please confirm the allowance of an Attachment section to hold things such as: Letters of reference, awards, etc. These documents will not count for points or as part of the total page count.**
- A-6 Correct. Attachments will not count against the total page count specified in the RFP.
- Q-7 Can we include Final Pay Apps in the Attachments section so you can read the content, instead of including them at an illegal size within the page count?**
- A-7 Yes.
- Q-8 Should the document be printed sheet facing (pg. 32) or double sided (Item HH on pg. 31)?**
- A-8 Item HH, on page 31 of the RFP requests that all pages in the proposal be double-sided, pursuant to County Resolution 2013-7. Page 32 of the RFP specifies that a “fold-out” page will be counted as 2 pages. Therefore, if the fold-out page is a single-sided document, it will count as 2 pages. If the fold-out page is double sided, it will be counted as 4 pages.
- Q-9 In the past performance section, does the required AIA G702 form and letters of recommendation count toward the total page limit of the RFP?**
- A-9 These items may be included as an attachment, and will not be counted against the total page count.
- Q-10 It was mentioned in the pre-bid that additional information could be provided in an separate tab which would be excluded from the page count. Can you please clarify if this is correct and what you would like this tab to be called/located since it was not listed in the evaluation criteria?**
- A-10 Additional information may be provided as an attachment. The Offeror may label or tab Attachments however they decide, but it is recommended that they be identified in the table of contents.
- Q-11 On pages 6 & 24, there are discrepancies concerning GRT as well as on the schedule of Services (December 2019/March 2020).**
- A-11 The MACC listed in the RFP is exclusive of NM GRT. The reference to the MACC listed on page 24 should read “exclusive” of NM GRT.
- Q-12 When will a Bid Bond be required?**

A-12 A Bid Bond will be required as part of the Phase II – document submittal as part of the Offerors cost proposal.

Q-13 Will the D-B Team be responsible to report to and meet with the Historic Board review?


A-13 The D-B Team will be required to meet with the Historic Board in conjunction with the County Project Team.

Q-14 Will the new Administration Building and the existing Administration Building be separate projects?

A-14 This is one project that involves sequencing and phased construction/renovation.

Please add Addendum No. 1 and this Addendum No. 2 to the original bid documents and refer to procurement documents, hereto as such. This and all subsequent addenda will become part of any resulting contract documents and have effects as if original issued. All other unaffected sections will have their original interpretation and remain in full force and effect.
