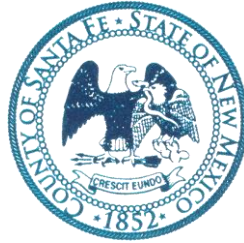

- Santa Fe County is requesting bids from licensed, qualified contractors to construct an all weather crossing on County Road 54 (Los Pinos Road) to improve and address drainage issues on County Road 54.
- Project Duration is a 120 days
- Liquidated Damages: \$1500 per each working day that expires after the date of substantial completion until substantial completion is achieved and a certificate of Substantial Completion is issued by the County.
