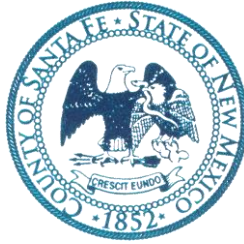

- Qualifications: Offerors at a minimum must hold both a GA-98 & GB-98 license and must be in good standing with New Mexico Construction Industries Division.
- Proposal Organization - Proposal should be organized as outlined in the RFP on page 22.
- Selection of finalist(s) – the most qualified proposal received based on the evaluation factors outlined in the RFP (pages 24-26) will be scored by a three to five member evaluation committee.
- Preferences -
 - 1) N.M. In-State Business Preference Certificate 5% of total weight of all evaluation factors added to score.

OR
