Questions and Responses

1. "Are we allowed to add GRT as a line item to be a direct pass through or do we need to have an all-inclusive rate to include GRT?" The Offeror may include GRT as a separate line item, clearly labeling the GRT rate and amount as included.

2. "The Insurance Requirements, Section II, part D requires the General Liability and Automobile insurance policy of \$1,000,000. However, the Sample Agreement, Section 28 asks for \$1,050,000. Please confirm which is the correct policy limit." The insurance requirement that is to be used for calculation is contained in the RFP and not in the Sample Contract.

Additional Information

During the Pre-Proposal teleconference, the following information was provided by the representative from the Corrections Department:

- a. The Nursing staff generally provided medications to approximately 400 inmates.
- b. They are also heavily involved in providing: physical assessments at intake for inmates: providing medical care for those in the detoxification area of the medical unit; providing tuberculosis testing; and, caring for the diabetic patients.
