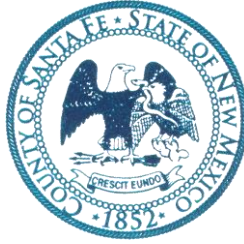

Question 1: I have a general question that is not addressed in the "scope of work" I would like to know the direction of SFC Fire with respect to this bid? Are they working toward NFPA-1851 compliance in this bid or do they just want post incident cleaning and repairs?

Response 1: We are working towards NFPA-1851 compliance.

Question 2: Can you explain your interpretation of "(including liner if applicable)" for A 1-10 and B 11-12. Do you want the price to include the liner or just the shell?

Response 2: Liner is included.

Question 3: What size of patch are you asking for on C 13, "Name Patch," and how many 2" reflective 3M letters do you want a price on?

Response 3: Patch = 12" x 8", Lettering varies by district so price per letter.

Question 4: What size of thread and what type of thread do you want a price on for D 16.

Response 4: Thread is NFPA compliant - NOMEX TEX80

Question 5: D 17 what width size do you want a quote on and do you want NFPA Compliant Velcro?

Response 5: NFPA compliant = 1 ½”

Question 6: What color of fabric do you want a price on for shell patches for D 19? Color affects the price.

Response 6: Gold & Black

Question 7: E 20 What type of hook do you want a price on?

Response 7: Delete hook.

Question 8: E 21-22 What NFPA Compliancy and what size are you asking for a price on?

Response 8: NFPA 1971 compliant and ½”

Question 9: F What type of trim are you asking for a price on?

Response 9: 3M reflective triple trim
