#### <u>Issue:</u>

On Sunday evening on July 25, 2021, the Public Works Department received an emergency call of an apparent water leak located at 3304 El Paseo in Hyde Park Estates in Santa Fe New Mexico.

Santa Fe County crews arrived at the site at approximately 7:00PM on July 25<sup>th</sup> to confirm the location of the water leak. Once located the street was isolated and the Department decided to contact Next Generation Contracting to help excavate and locate the specific cause of the leak. It was found that the water line located at 3304 El Paseo in Hyde Park Estates had broken in two and the water supply to 5 residents had to be shut off until the repairs were complete.

The system was repaired and water was resupplied to the residents on Monday July 26, 2021.

### <u>Determination:</u>

Due to the water supply to County residents was shut down to repair the leak, this resulted in a possible threat to the health and safety of the public.

It is therefore the determination of the County Procurement Manager, CPO that the services needed for the repairs located at the Hyde Park Estates location met the requirements of an emergency procurement, pursuant to NMSA 1978, 13-1-127.

All work and costs associated with this determination is limited to the services required for the repairs located at 3304 El Paseo in Santa Fe, New Mexico.
