

MEMORANDUM

Subject: Declaration of Emergency Determination

On August 6, 2013, a flood occurred which undermined the concrete retaining wall along Feather Road. The flood caused a large hole 70' long in the concrete structure near the bridge abatement. If this area is not repaired immediately, during the next flood event, it is possible that the bridge will be severely damaged.

On August 9, 2013, Santa Fe County Purchasing Division received a request from Public Works Department to declare an emergency condition concerning the failure of the bridge on Feather Road. The attached memorandum declares that the emergency condition exists pursuant to Section 13-1-127 NMSA 1978 and the immediate threat to the health and safety of the public and residents in Santa Fe County.

A purchase order was processed regarding the subject bridge damage.
