Project Information

- Santa Fe County Public Works is requesting bids for the purpose of procuring a licensed construction company for construction services for an expansion of the Madrid Fire Station.
- Project Duration: 180 working days where working days are defined as every day except Saturday, Sunday and holidays recognized by Santa Fe County.
- Liquidated Damages: \$150.00 per each working day that expires after the date of substantial completion until substantial completion is achieved and a certificate of Substantial Completion is issued by the County.
- Basis of Award: The lowest, <u>responsive</u> base bid. The County reserves the right to cancel the award if there are not sufficient appropriations available.

Qualifications:

- All contractors and subcontractors must be registered with the N.M. Department of Workforce Solutions for all work over \$60,000 on day of bid. All contractors and subs must be registered as "Active" the day of bid opening.
- Subcontractor Listing Form must be completed with all required information. For all trades that are listed "only one bid received" or "no bid received", the Contractors must list the name, city, county or place of business and the trade of all businesses contacted for quote.
- Request double-sided bid submittal in accordance with Santa Fe County Resolution 2013-7 "Adopting sustainable Resource Management Principals".
