On May 7, 2018, Santa Fe County Purchasing Division issued RFP #2018-0351-CMO/BT for surveying services for rights-of-way of County maintained roads within the Pueblos of Nambe, Tesuque, San Ildefonso and Pojoaque. Proposals were due on Thursday, May 31, 2018. Five (5) proposals were received from the following firms:

All proposals were deemed to be responsive and responsible proposals. The Evaluation Committee convened on Wednesday, June 6, 2018 to rate and rank the proposals. Pursuant to the requirements of the RFP, at least three firms were shortlisted. The following information lists the proposals in order of ranking:

It is the intent of Santa Fe County to begin negotiations with the top-ranked Firm of Precision Surveys, Inc. Pursuant to NMSA 1978, 13-1-120 through 13-1-124, if the County is unable to negotiate a satisfactory contract, negotiations may be terminated and the County would undertake negotiations with the second ranked Firm. This process will continue until a satisfactory contract is negotiated, or until the solicitation is canceled. After an award has been made, the appropriate selection committee's final ranking and evaluation scores for all proposals shall become public information. Once a contract has been awarded and your
