RE: Sole Source Determination per Section 13-1-126 NMSA 1978 to Continue Proprietary Software License and Upgrade to Current Election Systems with ROBIS Elections System, for a Total Amount of \$106,801.00, Inclusive of NM GRT.

BACKGROUND

In June 2021, the Santa Fe County Purchasing Clerk's Office procured Robis Elections, Inc. election software system utilizing the Statewide Price Agreement No. 40-370-13-00005AB. This software provided the Clerk's Office with a robust printing, mailing, general election help desk, mobile data, and absentee ballot messaging system. The system also provided for an absentee tracker/printing/mailing and ballot fee and postage accruals.

The Clerk's Office is requesting to continue the services with Robis Elections, Inc. to modify the current software system, with "Challenger Management and Check-in" for the systems vendor and Poll site tools, known as the AskED System-Hand Tally Manager.

The Secretary of State's Office requires the certification and re-certification of all polling equipment, by an "approved ballot on demand system". Robis and AES are only two systems that have this capability.

DETERMINATION

Based on the specific and proprietary nature of the software that is currently in place for the County Clerk's Office, and the new pre-requisites set by the Secretary of State's Office, the services are unique and is substantially related to the initial intended purpose of the original purchase of the Statewide Price Contract.

Further, due to the fact that Robis Elections, Inc. does not currently hold a Statewide Price Agreement or any other Cooperative Agreements, the County has determined that the procurement of the Robis Elections, Inc. license and system modifications is a sole source procurement, pursuant to 13-1-126, NMSA 1978.
