

**Amendment No. 5 to
Agreement No. 2021-0198-CORR/APS
Between Santa Fe County and SapphireHealth, LLC**

THIS AMENDMENT is made and entered into this 14th day of May, 2026, between **Santa Fe County** (the “County”), and **SapphireHealth, LLC** (the “Contractor”).

WHEREAS, the County and the Contractor entered into Agreement No. 2021-0198-CORR/APS (the “Agreement”) on November 10, 2021, to provide for the Contractor’s provision of electronic medical health reporting for inmates and staff at the Santa Fe County Adult Detention Facility; and

WHEREAS, Amendment Nos. 1, 2, 3 and 4 amended the Agreement to modify the Contractor’s services, increase the compensation payable to the Contractor, and extend the term to November 10, 2027; and

WHEREAS, by this Amendment. No. 5 the parties agree to amend the Agreement to increase the compensation payable to the Contractor and provide for certain cost increases for add-ons to the Health Records System.

NOW THEREFORE the parties agree to amend the Agreement as follows:

1. Article 3.A (Compensation, Invoicing and Set-Off), insert a subpart D to read:

D. By Amendment No. 5 the compensation payable to the Contractor is increased by the sum of \$37,513.20. The Contractor will be compensated in accordance with the fees and rates described in Contractor’s EHR Renewal Quote dated 22 April 2026 (Exhibit C). The additions entail one-time costs of \$10,500 for establishing access and development of forms and interfaces, as well as recurring costs of up to \$13,440 until November 2026 (modification year 1; contract year 5) and \$13,573.20 through November 2027 (modification year 2, contract year 6) for services and access.. The total amount payable to the Contractor for the term of this Agreement will not exceed **\$229,287.28**, *inclusive* of NM GRT.

2. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1 through 4 and this Amendment No. 5 will remain in full force and effect.

IN WITNESS WHEREOF, the parties have duly executed this Amendment No. 5 as of the date of last signature by the parties.


