

**AMENDMENT NO. 8
TO AGREEMENT BETWEEN SANTA FE COUNTY
AND GROWING UP NEW MEXICO**

THIS AMENDMENT is made and entered into this 28th day of August, 2026, between **Santa Fe County** (the “County”), and **Growing Up New Mexico** (the “Contractor”).

WHEREAS, on February 8, 2022, the County and Contractor entered into Agreement No. 2022-0154-CSD/TVR (the “Agreement”) to provide for the Contractor’s provision of navigation services and make flexible funds available to individuals who are low income and in need of Contractor’s services; and

WHEREAS, Article 15 (No Oral Modifications; Written Amendments required) of the Agreement allows the parties to amend the Agreement by an instrument in writing signed by the parties; and

WHEREAS, Amendments Nos. 1 through 7 increased the compensation payable to the Contractor and extended the term to February 8, 2027; and

WHEREAS, by this Amendment No. 8 the parties agree to amend the Agreement to increase the compensation payable to the Contractor.

NOW THEREFORE, the parties agree to amend the Agreement as follows:

1. Article 3.A.2 (Compensation, Invoicing and Set-Off), insert a subparagraph iii to read:
 - iii. By Amendment No. 8 the expenditure of the additional funding of \$107,800 will be designated for the same purposes as indicated above; that is, \$100,000 for navigation services and \$7,800 available as flexible funds.
2. Article 3.A.3 (Compensation, Invoicing and Set-Off) insert a subparagraph c to read:
 - c. By Amendment No. 8 the compensation payable to the Contractor is increased by the sum of \$107,800. The total amount of funds payable to the Contractor for the term of this Agreement will not exceed **\$689,000.00**, *inclusive* of NM GRT.
3. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1 through 7 and this Amendment No. 8 will remain in full force and effect.

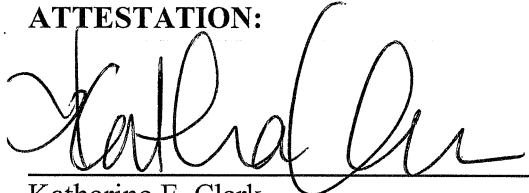
