

AMENDMENT NO. 7 TO AGREEMENT NO. 2022-0154-CSD/TVR

This Amendment is made this 17th day of February, 2026, between **Santa Fe County** (the "County"), and **Growing Up New Mexico** (the "Contractor").

WHEREAS, the County and Contractor entered into Agreement No. 2022-0154-CSD/TVR (the "Agreement") on February 8, 2022, to provide for the Contractor's provision of CONNECT navigation services and to make the use of flexible funds available to benefit the Contractor's clients; and

WHEREAS, Amendments Nos. 1 through 6 increased the compensation payable to the Contractor and extended the term to February 8, 2026; and

WHEREAS, the Contractor's services are not professional services as that term is defined in NMSA 1978, Section 13-1-76, of the Procurement Code and the contract amount is \$25,000 or more, therefore, the term is not limited to four years; and

WHEREAS, by this Amendment No. 7 the parties agree to amend the Agreement to extend the term for one year.

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Article 4 (Effective Date and Term) insert a subparagraph c to read:
 - c. By Amendment No. 7 the term is extended to February 8, 2027.
2. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1 through 6 and this Amendment No. 7 will remain in full force and effect.

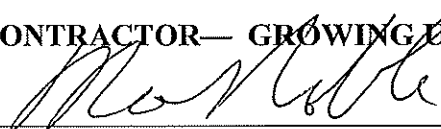

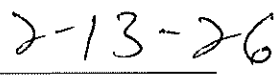
