

**AMENDMENT NO. 3
TO AGREEMENT BETWEEN SANTA FE COUNTY
AND CASA MILAGRO**

This Amendment is made this 6th day of July, 2026, between **Santa Fe County** (the “County”), and **Casa Milagro**, 49 Camino Bajo, Santa Fe, New Mexico 87508 (the “Contractor”).

WHEREAS, the County and Contractor entered into Agreement No. 2022-0264-A-CSD/MR (the “Agreement”) on July 11, 2022, to provide for the Contractor’s provision of CONNECT navigation services and to make flexible funds available to the Contractor to assist individuals who are low income; and

WHEREAS, Article 15 (No Oral Modifications, Written Amendments Required) allows the parties to amend the Agreement by an instrument in writing signed by the parties; and

WHEREAS, Amendments Nos. 1, 2 and 3 increased the compensation payable to the Contractor and extended the term to July 11, 2026; and

WHEREAS, the Contractor’s services are not “professional services” as that term is defined in NMSA 1978, Section 13-1-76, and pursuant to NMSA 1978, Section 13-1-150 (A), the contract amount is \$25,000 or more, therefore the term of this Agreement is not limited to four years; and

WHEREAS, by this Amendment No. 4 the parties agree to amend the Agreement to extend the term to July 11, 2027, and increase the compensation payable to the Contractor.

NOW THEREFORE, the parties agree to amend the Agreement as follows:

1. Article 3.A.2 (Compensation, Invoicing and Set-Off) insert a subparagraph iv to read:
 - (iv) By Amendment No. 4 the expenditure of the additional funding of \$32,340.00 will be designated for the same purposes as indicated above; that is \$30,000 for navigation services and \$2,340 for flexible funds.
2. Article 3.A.1 (Compensation, Invoicing and Set-Off), insert a subparagraph d to read:
 - (d) By Amendment No. 4 the compensation payable to the Contractor is increased by the sum of \$32,340. The total amount of funds payable to the Contractor for the term of this Agreement will not exceed **\$161,700.00** *inclusive* of NM GRT.
3. Article 4 (Effective Date and Term) insert a subparagraph b to read:
 - (b) By Amendment No. 4 the term is extended to July 11, 2027. By Amendment No. 4 this is a multi-term contract under Section 50 of the Santa Fe County Purchasing Regulations and

NMSA 1978, Section 13-1-150 (Multi-term contracts, specified period). Pursuant to Section 50 (D) of the Purchasing Regulations, and NMSA 1978, Section 13-1-152 (Multi-term contracts; cancellation due to unavailability of funds), if funds are not appropriated or otherwise made available to support compensation payable to the Contractor for the 5th fiscal year, this Agreement will be cancelled.

4. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1, 2, 3 and this Amendment No. 4 will remain in full force and effect.

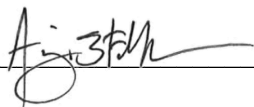
