

**AMENDMENT NO. 4
TO THE AGREEMENT BETWEEN SANTA FE COUNTY
AND SANTA FE PUBLIC SCHOOLS ADELANTE PROGRAM**

This Amendment is made this 30th day of June 2026, between **Santa Fe County** (the "County") and **Santa Fe Public Schools Adelante Program** (the "Contractor").

WHEREAS, on June 29, 2022, the County and Contractor entered into Agreement No. 2022-0268-CSD/MR (the "Agreement"), to provide for the Contractor's provision of CONNECT navigation services and to make flexible funds available to students and their families as part of the Contractor's Adelante Program; and

WHEREAS, Article 15 (No Oral Modifications, Written Amendments Required) allows the parties to amend the Agreement by an instrument in writing signed by the parties; and

WHEREAS, the Contractor's services under this Agreement are not "professional services" as that term is defined in NMSA 1978, Section 13-1-76, and pursuant to NMSA 1978, Section 13-1-150 (A), the contract amount is \$25,000 or more, therefore the term of this Agreement is not limited to four years; and

WHEREAS, by Amendments Nos. 1, 2 and 3 the compensation payable to the Contractor was increased and the term was extended to June 29, 2026; and

WHEREAS, by this Amendment No. 4 the parties agree to amend the Agreement to increase the compensation payable to the Contractor and extend the term to June 29, 2027.

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Article 3.A.2 (Compensation, Invoicing and Set-Off) insert a subparagraph iv to read:

(iv) By Amendment No. 4 the expenditure of the additional funding of \$107,800.00 will be designated for the same purposes as indicated above; that is \$100,000.00 for navigation services and \$7,800.00 for flexible funds.

2. Article 3.A.3 (Compensation, Invoicing and Set-Off) insert a subparagraph d to read:

(d) By Amendment No. 4 the compensation payable to the Contractor is increased by the sum of \$107,800. The total amount of funds payable to the Contractor for the term of this Agreement will not exceed **\$539,000.00**, inclusive of NM GRT.

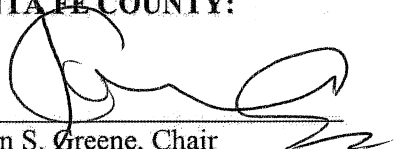
3. Article 4 (Effective Date and Term) insert a subparagraph b to read:

(b) By Amendment No.4 the term is extended to June 29, 2027.

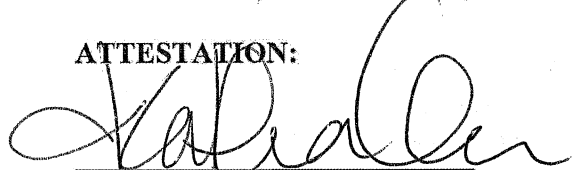

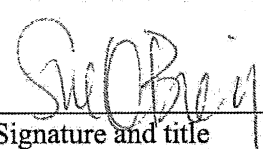
