

**AMENDMENT NO. 3
TO THE AGREEMENT BETWEEN SANTA FE COUNTY
AND SANTA FE PUBLIC SCHOOLS TEEN PARENT PROGRAM**

This Amendment is made this 13th day of August 2025, between Santa Fe County (the "County") and Santa Fe Public Schools Teen Parent Program (the "Contractor").

WHEREAS, the County and Contractor entered into Agreement No. 2022-0269-A-CSD/MR (the "Agreement") on June 29, 2022, to provide for the Contractor's provision of CONNECT navigation services and to make flexible funds available to students and their families; and

WHEREAS, Article 15 (No Oral Modifications, Written Amendments Required) allows the parties to amend the Agreement by an instrument in writing signed by the parties; and

WHEREAS, Amendment No. 1 increased the compensation payable to the contractor by the sum of \$78,155. Amendment No. 2 extended the term to June 29, 2026, and increased the compensation payable to the Contractor by the sum of \$78,155; and

WHEREAS, by this Amendment No. 3 the parties agree to increase the compensation payable to the Contractor by the sum of \$78,155.

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

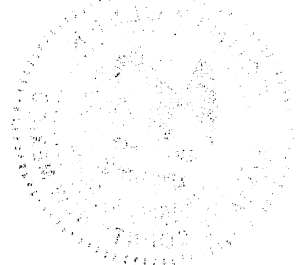
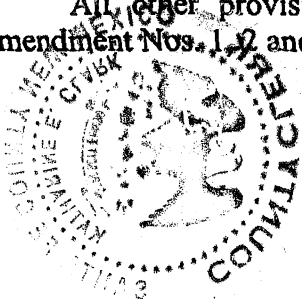
1. Article 3.A.2 (Compensation, Invoicing and Set-Off) insert a subparagraph c to read:

c. By Amendment No. 3 the expenditure of the additional funding of \$78,155.00 will be designated for the same purposes as indicated above; that is \$72,500.00 for navigation services and \$5,655.00 for flexible funds.

2. Article 3.A.1 (Compensation, Invoicing and Set-Off) insert a subparagraph d to read:

d. By Amendment No. 3 the compensation payable to the Contractor is increased by the sum of \$78,155.00. The total compensation payable to the Contractor for the term of this Agreement will not exceed \$301,840.00 inclusive of NM GRT.

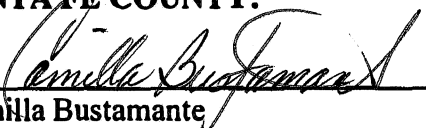
3. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1, 2 and this Amendment No. 3 will remain in full force and effect.



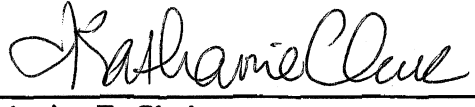

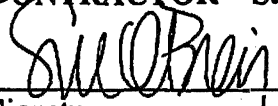

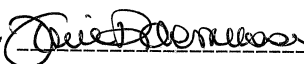
