

Amendment No. 6 to Agreement No. 2022-0140-CSD

This Amendment is made this 8th day of September, 2026, between **Santa Fe County** (the “County”), and **The Life Link** (“Life Link”).

WHEREAS, the County and Life Link entered into Memorandum of Agreement No. 2022-0140-CSD/MM (the “MOA”) on March 22, 2022, to provide for Life Link to serve as fiscal intermediary for the LEAD-Santa Fe County Community Outreach Fund; and

WHEREAS, Life Link’s services under this MOA are not “professional services” as that term is defined in NMSA 1978, Section 13-1-76, and pursuant to NMSA 1978, Section 13-1-150 (A), the contract amount is \$25,000 or more, therefore the term of this MOA is not limited to four years; and

WHEREAS, according to Article 11 of the MOA (Amendment), the parties may amend the MOA by an instrument in writing signed by the parties; and

WHEREAS, Amendment No. 1 extended the term and increased the compensation payable to Life Link; Amendment Nos. 2 and 3 extended the term to December 31, 2025; Amendment No. 4 increased the compensation payable to Life Link; Amendment No. 5 extended the term to December 31, 2026; and

WHEREAS, by this Amendment No. 6 the parties agree to amend the MOA to increase the compensation payable to Life Link by the sum of \$41,120 and extend the term to December 31, 2027.

WHEREAS, the parties agree to amend the MOA as follows:

NOW THEREFORE, the parties agree as follows:

1. Article 3 (Funding) insert a subparagraph d to read:
 - d. By Amendment No. 6 the sum of \$41,120 is made available for reimburse Life Link for eligible costs and services performed for the County’s law enforcement assisted diversion program from December 31, 2026 to December 31, 2027. The Life Link will continue to service as a fiscal intermediary for the categories of service listed below:
 - i. Housing Funds \$24,000.00
 - ii. Wellness Funds \$15,042.00
 - iii. Community Outreach \$ 499.00
 - iv. 4% Administrative fee \$ 1,579.00

The total amount of funds available to Life Link for the term of this MOA will not exceed **\$296,064.00**, inclusive of the 4% administration fee payable to Life Link as provided in the MOA.

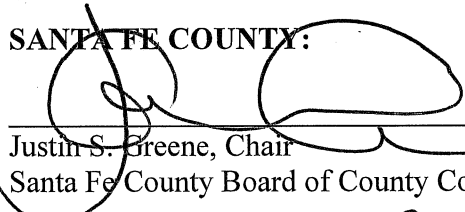
2. Article 4 (Term) is amended by inserting a subparagraph e to read:

e. By Amendment No. 6 the term is extended to December 31, 2027.

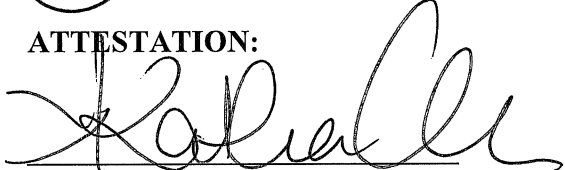
