

**AMENDMENT NO. 3
TO AGREEMENT NO. 2023-0010-CSD/CW**

This Amendment is made this 28th day of Oct, 2025, between **Santa Fe County** (the "County") and **La Familia Medical Center** (the "Contractor").

WHEREAS, on August 30, 2022, the County and Contractor entered into Agreement No. 2023-0010-CSD/CW (the "Agreement") as part of the Health Care Assist (HCAP) navigation services initiative by the Santa Fe County Community Services Division. Under the Agreement the Contractor is to provide navigation services to County residents, including utilizing our CONNECT network to meet the needs of County residents for the social determinants of health, such as food, housing, utilities, and transportation; and

WHEREAS, Article 15 (No Oral Modifications; Written Amendments Required) of the Agreement allows parties to amend the Agreement by an instrument in writing signed by the parties; and

WHEREAS, Amendment Nos. 1 and 2 increased the compensation payable to the Contractor and extended the term to August 30, 2025; and

WHEREAS, by this Amendment No. 3 the parties agree to amend the Agreement to increase the compensation payable to the Contractor and extend the term to August 30, 2026.

NOW, THEREFORE, the parties hereto agree to amend the Agreement as follows:

1. Article 3.A.1 (Compensation, Invoicing, and Set-Off) insert a subpart iii to read:

- iii. By Amendment No. 3 the compensation payable to the Contractor is increased by the sum of \$746,050. The total amount payable to the Contractor for the term of this Agreement will not exceed **\$2,984,200.00**, *inclusive* of NM GRT.

2. Following the table in Article 3.B.2 (Compensation, Invoicing and Set-Off), insert a subpart iii to read:

- iii. By Amendment No. 3 of the \$746,050 of additional compensation, \$706,050 will be available in FY 2026 to compensate Contractor for the above described navigation services.

3. Article 3. B. 3 (Compensation, Invoicing and Set-Off), insert a subpart iii to read:

- iii. By Amendment No. 3 of the 746,050 of additional

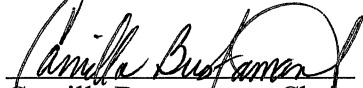

compensation, \$10,000 will be available in FY 2026 to reimburse Contractor for costs relating to providing DME for HCAP-eligible patients for a maximum of three months per patient per year.

4. Article 3.B.4 (Compensation, Invoicing and Set-Off) insert a subpart iii to read:
 - iii. By Amendment No. 3 of the \$746,050 of additional compensation, \$30,000 will be available in FY 2026 to reimburse Contractor for eligible expenses from the Flexible Fund.
5. Article 4 (Effective Date and Term) insert a subparagraph c to read:
 - c. By Amendment No. 3 the term is extended to August 30, 2026.
6. All other provisions of the Agreement not specifically amended or modified by this Amendment No. 3 will remain in full force and effect.

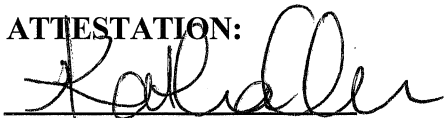

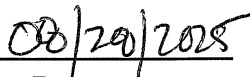

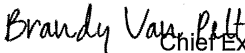
