

**AMENDMENT NO. 3  
TO AGREEMENT NO. 2024-0265-PW/BT BETWEEN SANTA FE COUNTY AND  
INTERA, INC.**

**THIS AMENDMENT** is made this 28<sup>th</sup> day of April, 2026, between **Santa Fe County** (the “County”), and **Intera, Inc.** (the “Contractor”) to Agreement No. 2024-0265-PW/BT (the “Agreement”) between the County and the Contractor for engineering services pertaining to the presence of PFAS contaminates in the areas of La Cienega and La Cieneguilla, in Santa Fe County; and.

**WHEREAS**, Amendment Nos. 1 and 2 amended the Agreement to extend the term of the Agreement to August 25, 2026, and to incorporate the use of additional funding for groundwater sampling; and

**WHEREAS**, the Contractor has reviewed, complied, and evaluated existing data sets; refined the groundwater modeling and particle tracking analysis; and collected additional drinking water and surface water samples across the communities of La Cienega and La Cieneguilla; and

**WHEREAS**, the Contractor has identified an area encompassing most of the La Cieneguilla community in which groundwater is impacted by PFAS contamination, with PFAS concentrations across a substantial portion of the affected area exceeding New Mexico Environment Department and United States Environmental Protection Agency drinking water standards; and

**WHEREAS**, the Contractor’s work has improved the overall understanding of PFAS conditions in both La Cienega and La Cieneguilla communities, however uncertainties remain regarding the source of contamination in La Cieneguilla, its vertical and horizontal extent, compound-specific fate and transport process, and other PFAS and hydrogeologic factors relevant to remedial action decision-making; and

**WHEREAS**, the term of the Agreement is due to expire August 27, 2026, and the parties agree to amend the Agreement to extend the term; and

**WHEREAS**, according to Section 14 (Amendment), the Agreement can be amended by an instrument in writing signed by the parties. By this Amendment No. 3 the parties agree to amend the Agreement to provide for Additional Services to be performed and completed by the Contractor pertaining to uncertainties stated above regarding the presence of PFAS in the La Cieneguilla community and to extend the term to August 27, 2027.

**NOW THEREFORE**, the parties agree to amend the Agreement as follows:

1. Article 2 (Additional Services) insert a paragraph C to read:

C. By Amendment No. 3 the Contractor will perform and complete the Additional Services described by the Contractor as Task Nos. 1, 2, 3, 4, 6, 7, and 8 in the Contractor’s proposal and cost estimate dated April 6, 2026 (see Attachment A).

2. Article 3 (Compensation, Invoicing and Set-Off), insert subparagraphs B.1 and (i) to read:

B.1 By Amendment No. 3, the compensation payable to the Contractor for performance and completion of Additional Services is based on the following fee schedule.

3. Article 4 (Effective Date and Term) insert a subparagraph b to read:

b. By Amendment No. 3 the term is extended to August 27, 2027.

4. All other provisions of Agreement not specifically amended or modified by Amendment Nos. 1, 2 and this Amendment No. 3 will remain in full force and effect.


