

**AMENDMENT NO. 8
TO AGREEMENT BETWEEN SANTA FE COUNTY
AND YOUTHWORKS**

THIS AMENDMENT is made and entered into this 28th day of August, 2026, between **Santa Fe County** (the “County”), and **Youthworks** (the “Contractor”).

WHEREAS, on February 8, 2022, the County and Contractor entered into Agreement No. 2022-0155-CSD/TVR (the “Agreement”) to provide for the Contractor’s provision of navigation services including flexible funds; and

WHEREAS, Article 15 (No Oral Modifications; Written Amendments required) of the Agreement allows the parties to amend the Agreement by an instrument in writing signed by the parties; and

WHEREAS, Amendments Nos. 1 through 7 increased the compensation payable to the Contractor and extended the term to February 8, 2027; and

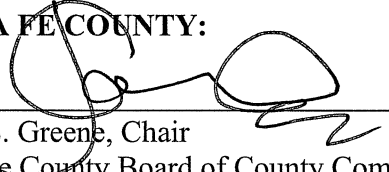
WHEREAS, by this Amendment No. 8 the parties agree to amend the Agreement to increase the compensation payable to the Contractor.

NOW THEREFORE, the parties agree to amend the Agreement as follows:

1. Article 3.A.1.(Compensation, Invoicing and Set Off), insert a subparagraph d to read:
 - d. By Amendment No. 8 the expenditure for the additional funding of \$100,000 will be designated for allowable uses of flexible funds.
2. Article 3.A.2. (Compensation, Invoicing and Set-Off) insert a subparagraph d to read:
 - d. By Amendment No. 8 the compensation payable to the Contractor is increased by the sum of \$100,000. The total amount of funds payable to the Contractor for the term of this Agreement will not exceed **\$825,000.00**, *inclusive* of NM GRT.
3. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1 through 7 and this Amendment No. 8 will remain in full force and effect.

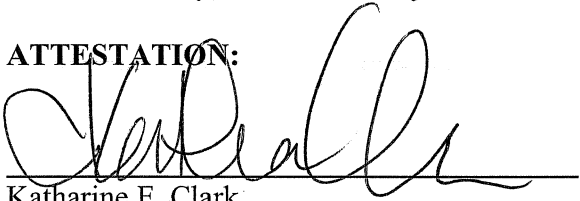

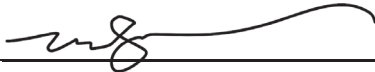
