**AMENDMENT NO. 1
TO MEMORANDUM OF UNDERSTANDING NO. 2026-0252-CSD**

THIS AMENDMENT is entered into this 22nd day of July, 2026, between Santa Fe County DWI Program (the "County"), and New Mexico State Police Department ("NMSPD").

WHEREAS, the County and NMSPD entered into Memorandum of Understanding No. 2026-0252-CSD (the "MOU") on March 10, 2026, to provide for funding in the amount of \$7,500.00 from the County to NMSPD to provide assistance to the NMSPD in its enforcement of DWI laws and DWI and DUI prevention activities. The term of the MOU is due to expire June 30, 2026; and

WHEREAS, by this Amendment No. 1 the parties agree to amend the MOU to extend the term of the MOA for another year and provide for \$15,000.00 in funding from the County to NMSPD for the enforcement of DWI laws and other DWI and DUI prevention activities for another year.

NOW THEREFORE, the parties agree to amend the MOU as follows:

1. Insert a paragraph 8 to read:

8. By Amendment No. 1 to this MOU the parties agree to amend this MOU to extend the term from to June 30, 2026, to June 30, 2027, and provide for a continuation of funding from the County DWI Program to the New Mexico State Police Department in the amount of \$15,000.00. The total amount to be expended during the term of July 1, 2026, to June 30, 2027, will not exceed \$15,000.00 and is to be spent prior to June 30, 2027

2. All other provisions of the MOU not specifically amended or modified by this Amendment No. 1 will remain in full force and effect.

IN WITNESS WHEREOF, the parties have executed this Amendment No. 1 as of the date this Amendment is fully executed by both parties and will continue to be in effect until June 30, 2027.

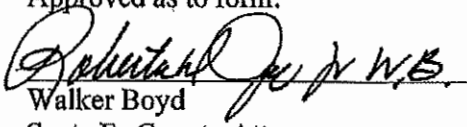

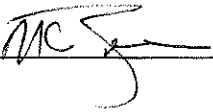
