

**AMENDMENT NO. 2
TO SANTA FE COUNTY
PROFESSIONAL SERVICES AGREEMENT
WITH BOYS AND GIRLS CLUBS OF SANTA FE
TO PROVIDE AFTER SCHOOL AND SUMMER PROGRAM SERVICES**

THIS AMENDMENT is made and entered into as of this 12 day of April, 2012, by and between the **Santa Fe County**, hereinafter referred to as ("the County"), and **Boys and Girls Clubs of Santa Fe**, a non-profit organization with a principal address located at 730 Alto Street, Santa Fe, NM 87501, hereinafter referred to as "the Contractor".

WHEREAS, pursuant to NMSA 1978, Sections 13-1-112 and 13-1-117, competitive, sealed proposals were solicited via a formal request for proposals, RFP No. 2010-0369-HO/TRV, for the provision of the professional services;

WHEREAS, the County determined Contractor as the most responsive and highest rated offeror and the County and Contractor entered into Agreement No. 2010-0369-HO/TRV dated June 30, 2010;

WHEREAS, pursuant to Agreement No. 2010-0369-HO/TRV, for a term of four years and a not-to-exceed amount of \$445,000, Contractor will develop, implement and operate an on-site after-school and summer youth program for County public housing and neighborhood community centers;

WHEREAS, Amendment No. 1 amended the Agreement to provide for a \$30,000.00 decrease in the Contractors compensation for Fiscal Year 2012;

WHEREAS, the Housing Department requests to amend the Agreement to provide for a \$15,000.00 increase in the Contractors compensation for Fiscal Year 2012;

WHEREAS, pursuant to Paragraph 17 of the Agreement the parties may amend the agreement by an instrument in writing executed by the parties.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

1. In Paragraph 2.A, the reference to "\$430,000.00" is deleted and replaced with "\$445,000.00".
2. In Paragraph 2.A, the reference in subparagraph 2.A.b. to "\$85,000" is deleted and replaced with "\$100,000".
3. All other provisions of the Agreement not amended or replaced by Amendment No. 1 and this Amendment No. 2 remain in full force and effect.
