

**AMENDMENT NO. 2
PROFESSIONAL SERVICE AGREEMENT
BETWEEN SANTA FE COUNTY AND
JOAN MORALES, LISW
FOR CLINICAL ASSESSMENT SERVICES**

THIS AMENDMENT is made and entered into this 29 day of May 2019, by and between SANTA FE COUNTY, (hereinafter the "County") and JOAN MORALES, LISW (hereinafter the "Contractor".)

WHEREAS, on November 30, 2017, the County and Contractor entered into Agreement No. 2018-0049-CSD/MAM (the Agreement) to provide for the Contractor's provision of DWI Clinical Assessment services; and

WHEREAS, by Amendment No. 1 the term of the Agreement was extended to June 30, 2019; and

WHEREAS, the County wishes to continue to benefit from Contractor's services and extend the term of the Agreement to June 30, 2020; and

WHEREAS, amend the Contractor's scope of work and increase the compensation payable to the Contractor by the sum of \$65,000.00.

NOW, THEREFORE, the parties agree as follows:

1. Section 1 (Scope of Work) is amended by inserting subparagraph K to read:

K. By Amendment No.2 to this Agreement, Contractor will increase the number of client assessments performed to a minimum of 18 per month.
2. Section 3.A.2 (Compensation, Invoicing, and Set-OFF), is amended by inserting the following as subpart A to read:

A. By Amendment No. 2, to this Agreement, the compensation payable to the Contractor for the term of June 30, 2019 to June 30, 2020 is increased by \$65,000.00. The amount payable to the Contractor for the term of this Agreement shall not exceed \$107,225.56 exclusive of NM grt. Any New Mexico gross receipts tax levied on the amounts payable under this Agreement shall be paid by the County to the Contractor.
3. Section 4 (Effective Date and Term) is amended by inserting subpart B to read:


B. By Amendment No. 2 to this Agreement, the term of this Agreement

is extended from June 30, 2019 to June 30, 2020, unless earlier terminated pursuant to Section 4 (Termination) or 5 (Appropriations) of this Agreement.

4. All other provisions of the Agreement not specifically amended or modified by Amendment No. 1 and this Amendment No. 2 shall remain in full force and effect.
