

**AMENDMENT NO. 2  
TO PRICE AGREEMENT BETWEEN  
SANTA FE COUNTY AND  
DESERT MOUNTAIN CORPORATION**

THIS AMENDMENT is entered into this 29<sup>th</sup> day of January, 2020, by and between **Santa Fe County**, hereinafter "County", and **Desert Mountain Corporation**, hereinafter "Contractor".

**WHEREAS**, on January 29, 2018, the County and Contractor entered into Agreement No. 2018-0183-A-PW/KE (Price Agreement) for Contractor to provide the delivery of rock salt for ice and snow removal; and

**WHEREAS**, the term of the Price Agreement is due to expire January 29, 2020, and the County wishes to continue to benefit from Contractor's services; and

**WHEREAS**, according to Article 7 (Amendment), the parties may amend the Price Agreement by an instrument in writing; and


**WHEREAS**, by Amendment No. 1 Agreement was amended to extend the term to January 29, 2020. By this Amendment No. 2 the parties agree to extend the term of the Price Agreement to January 29, 2021.

**NOW THEREFORE**, the parties agree to amend the Price Agreement as follows:

1. Article 4 (Term), a subpart B is inserted to read:
  - B. By Amendment No. 2 the term of this Price Agreement is extended for one year from January 29, 2020, to January 29, 2021.
2. All other provisions of the Price Agreement not specifically amended or modified by Amendment No. 1 and this Amendment No. 2, shall remain in full force and effect.
