

**AMENDMENT NO. 1  
TO SERVICES AGREEMENT BETWEEN  
SOTO ENTERPRISES, INC. (D/B/A MIRACLE DELIVERY ARMORED SERVICE)  
AND SANTA FE COUNTY**

**THIS AMENDMENT** is made and entered into as of this 21 day of May, 2014, by and between Santa Fe County, hereby referred as the "County" and Soto Enterprises, Inc. (hereby referred as "MDAS").

**WHEREAS**, on September 5, 2013 the County and MDAS entered into Services Agreement No. 2014-0060-CORR/GG and Addendum to provide services for pick-up and receive funds, securities, instruments, and/or valuable articles for the Santa Fe County Adult Detention Facility;

**WHEREAS**, Services Agreement No. 2014-0060-CORR/GG is due to expire on July 30, 2014;

**WHEREAS**, pursuant to Paragraph 1 of the Addendum to Service Agreement No. 2014-0060-CORR/GG, the County has the option to extend the term of the Agreement in one-year increments;

**WHEREAS**, the parties desire to enter into this Amendment No. 1 to extend the term of the Service Agreement from July 30, 2014 to June 30, 2015 and increase MDAS' compensation for the continuation of services for one (1) year.

**NOW, THEREFORE, IT IS AGREED AS FOLLOWS:**

1. Paragraph 1, "Term" of the Addendum to Service Agreement No. 2014-0060-CORR/GG is amended by inserting subparagraph "(a)" to read as follows:
  - (a) Pursuant to Amendment No. 1 the term of this Service Agreement is extended for one (1) year beginning July 30, 2014 and terminating June 30, 2015.
2. Paragraph 3, "Compensation" of the Addendum to Service Agreement No. 2014-0060-CORR/GG is amended by inserting subparagraph "(a)" to read as follows:
  - (a) Pursuant to Amendment No. 1 to extend the term of this Agreement from July 30, 2014 to June 30, 2015, the total amount payable for this term extension, exclusive of gross receipts tax, shall not exceed Two Thousand Two Hundred Ninety-Nine Dollars and Ninety-Four Cents (\$2,299.94).
3. All other provisions of Service Agreement No. 2014-0060-CORR/GG and Addendum not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
