

**AMENDMENT NO. 3
TO THE AGREEMENT BETWEEN
SANTA FE COUNTY AND ZANA BURNS**

THIS AMENDMENT is made and entered into this 23rd day of May, 2017, between **Santa Fe County**, hereinafter referred to as the "County", a New Mexico political subdivision, and **Zana Burns**, hereafter referred to as the "Contractor."

WHEREAS, on June 27, 2014 the County and Contractor entered into Agreement No. 2015-0002-CSD/PL (Agreement) for the Contractor's provision of substance abuse programs to Teen Court participants; and

WHEREAS, the Agreement is due to expire June 27, 2017, and the County wishes Contractor to continue to provide substance abuse programs; and

WHEREAS, Article 15 (No Oral Modifications; Written Amendments Required) of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, the parties desire to enter into this Amendment No. 3 to extend the term of the Agreement from June 27, 2017 to June 27, 2018, and increase the Contractor's compensation by a sum of \$4,500.00 for a total contract sum of \$13,500.00, inclusive of NM grt.

NOW THEREFORE, the parties agree to amend the Agreement as follows:

1. Article 2.A.2) is amended by inserting a subparagraph "c" to read:
 - c. By Amendment No. 3 extending the term of this Agreement from June 27, 2017 to June 27, 2018, for this period the County shall pay to the Contractor \$4,500.00, inclusive of NM grt. The total amount payable to the Contractor during the term of this Agreement shall not exceed \$18,000.00, inclusive of NM grt.

2. Article 3 (Effective Date and Term) of the Agreement is amended by inserting a subparagraph "c" to read:
 - c. By Amendment No. 3 the term of this Agreement is extended from June 27, 2017 to June 27, 2018. Contractor's services shall be performed and invoiced within the period of June 27, 2017 to June 27, 2018.

3. All other provisions the Agreement not specifically amended or modified by Amendment No. 1, 2 and this Amendment No. 3 shall remain in full force and effect.
