

**AMENDMENT NO. 5 TO SERVICE AGREEMENT
BETWEEN SANTA FE COUNTY AND
GRANICUS, LLC dba HOST COMPLIANCE**

THIS AMENDMENT is made this 18th day of March 2024, between **Santa Fe County** (the "County"), and **GRANICUS, LLC dba HOST COMPLIANCE** (the "Contractor").

WHEREAS, on July 17, 2020, the County and Contractor entered into Agreement No. 2020-0180-GM, (the "Agreement") to provide for the Contractor's provision of technical, analytical and administrative support services to aid the County in the development, implementation and management of short term rentals ("STR") in the County; and

WHEREAS, according to Article 16 (No Oral Modifications; Written Amendments Required) of the Agreement, the Agreement may be amended by an instrument in writing signed by the parties; and

WHEREAS, Amendment Nos. 1, 2, 3 and 4 to the Agreement amended the Agreement to provide for the County's provision of GIS data for use by the Contractor in performing the services, increased the compensation payable to the Contractor and extended the term of the Agreement to July 17, 2024; and

WHEREAS, by this Amendment No. 5 the parties wish to amend the Agreement to increase the compensation payable to the Contractor by the sum of \$33,972.83 and extend the term to July 17, 2025,

NOW, THEREFORE, the parties agree to amend the Agreement as follows.

1. Article 4.A.2 (Compensation, Invoicing and Set-Off) insert a subparagraph d to read:

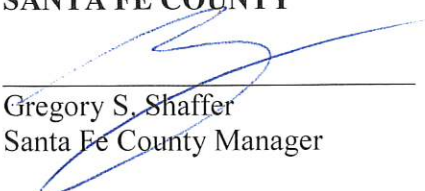
d. By Amendment No. 5 to this Agreement the compensation payable to the Contractor is increased by the sum of **\$33,972.83**. The total amount payable to the Contractor for the term of this Agreement will not exceed **\$239,756.62**, *exclusive* of NM GRT.
2. Article 5 (Effective Date and Term) insert a subparagraph D to read:

D. By Amendment No. 5 to this Agreement the term is extended to July 17, 2025.
3. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1, 2, 3, 4 and this Amendment No. 5 will remain in full force and effect.
