

**AMENDMENT NO. 8 TO SERVICE AGREEMENT
BETWEEN SANTA FE COUNTY AND
HOST COMPLIANCE**

THIS AMENDMENT is entered this 30th day of June 2026, between **Santa Fe County** (the "County"), and **GRANICUS, LLC dba HOST COMPLIANCE** (the "Contractor").

WHEREAS, on July 17, 2020, the County and Contractor entered into Agreement No. 2020-0180-GM (the "Agreement") to provide for the Contractor's provision of technical, analytical and administrative support services to aid the County in the development, implementation and management of short-term rentals in the County; and

WHEREAS, Amendment Nos. 1 through 7 amended the Agreement to provide for the County's provision of GIS data, increased the compensation payable to the Contractor and extended the term to July 16, 2026; and

WHEREAS, the Procurement Manager determines that the Contractor's services are not "professional services" as that term is defined in NMSA 1978, Section 13-1-76, and the amount of the Agreement is \$250,000 or more, therefore the term of the Agreement is not limited to four years; and

WHEREAS, by this Amendment No. 8 the parties agree to amend the Agreement to update some of the information in the Agreement, extend the term for one year and increase the compensation payable to the Contractor.

NOW, THEREFORE, the parties agree to amend the Agreement as follows.

1. Article 4.A.2 (Compensation, Invoicing and Set-Off) insert a subparagraph g to read:

g. By Amendment No. 8 the compensation payable to the Contractor is increased by the sum of \$136,702.64. The total compensation payable to the Contractor for the term of this Agreement will not exceed \$625,005.78, *exclusive* of NM GRT.

2. Article 4.B.1 (Compensation, Invoicing and Set-Off), delete "Chris Hyer, Economic Development Manager, 100 Catron Street, (505) 995-2728" and replace with Joseph Martinez, Code Enforcement Supervisor, 240 Grant Avenue, Santa Fe, (505) 995-6531, respectively.

3. Article 7 (Effective Date and Term) insert a subparagraph G to read:

G. By Amendment No. 8 the term is extended to July 16, 2027.

4. Article 24 (Notices), for the County's point of contact delete "Growth Management Department", "Chris Hyer", "Economic Development Manager"

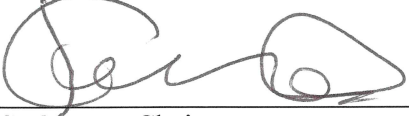

and "100 Catron" and replace with Joseph Martinez, Code Enforcement Supervisor and 240 Grant Avenue, respectively.

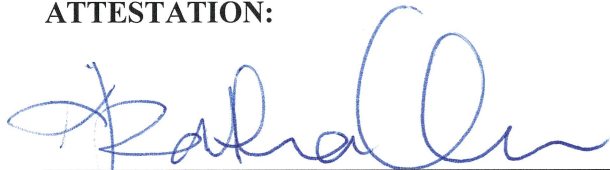
5. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1 through 7 and this Amendment No. 8 will remain in full force and effect.

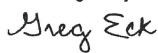
