

**AMENDMENT NO. 9
TO AGREEMENT BETWEEN SANTA FE COUNTY AND
IRON MOUNTAIN INFORMATION MANAGEMENT, LLC**

THIS AMENDMENT is made this 12th day of May, 2026, between **Santa Fe County** (the “County”) and **Iron Mountain Information Management, LLC** (the “Contractor”).

WHEREAS, the County and Contractor entered into Agreement No. 2017-0196-ASD/KE (the “Agreement”) on May 15, 2017, to provide for the Contractor’s provision of record storage and management services and to archive records and documents for the County consistent with the County’s record retention policies and schedules; and

WHEREAS, Articles 3 and 15 of the Agreement allow the County to extend the term of the Agreement and to amend the Agreement by an instrument in writing signed by the parties; and

WHEREAS, Amendment Nos. 1 through 8 amended the Agreement to extend the term and incorporate certain price increases; and

WHEREAS, by this Amendment No. 9 the parties agree to amend the Agreement to extend the term to May 15, 2027, increase the compensation payable to the Contractor, and replace the pricing schedule with an updated pricing schedule.


NOW THEREFORE, the parties agree to amend the Agreement as follows:

1. Article 2.A.1 (Compensation and Invoicing) insert a subparagraph i to read
 - i. By Amendment No. 9 the rate schedule referenced in the Agreement as “8th Revised Schedule A: PROGRAM PRICING SCHEDULE” is deleted and replaced with the attached rate schedule titled “9th Revised SCHEDULE A: PROGRAM PRICING SCHEDULE.” These rates and prices are effective May 15, 2026.
2. Article 2.A.2. (Compensation and Invoicing) insert a subparagraph g to read:
 - g. By Amendment No. 9 the compensation payable to the Contractor is increased by the sum of \$85,000. The total amount payable to the Contractor for the term of this Agreement will not exceed \$684,500.00, *exclusive* of NM GRT.
3. Article 3 (Effective Date and Term), insert a subparagraph D to read:
 - D. By Amendment No. 9 the term is extended to May 15, 2027
4. All provisions of the Agreement not specifically amended or modified by Amendment


Nos. 1 through 8 and this Amendment No. 9 will remain in full force and effect.
