

# AMENDMENT TO AGREEMENT TERMS AND CONDITIONS

## SANTA FE COUNTY AND MANATRON, INC.

CONTRACT NO. 27-1910-AS/RM

THIS AMENDMENT is made and entered into this 4<sup>TH</sup> day of 2008, 2008, by and between Santa Fe County, a political subdivision of the State of New Mexico, hereinafter referred to as the "County" and Manatron, Inc., a Michigan corporation, licensed to do business in New Mexico, hereinafter referred to as "Manatron".

**WHEREAS**, the County and Manatron are parties to that certain Agreement, dated January 30, 2008, to provide an integrated GIS and CAMA system for Santa Fe County ("the Agreement"); and

**WHEREAS**, the parties desire to amend the Agreement to clarify the performance bond requirement.

**NOW THEREFORE**, in consideration of the mutual covenants and conditions contained herein, it is mutually agreed between the parties as follows.

### AGREEMENT


1. Paragraph 14 of the Agreement is hereby amended to read as follows:

#### **"14. PERFORMANCE BOND:**

14.1 Performance Bond. Manatron agrees to post a performance bond in the amount of one hundred percent (100%) of the one-time fees as defined on the Summary Schedule. The bond shall cover the Warranty period of this Agreement, as defined in Section 10.1 herein. In addition, the performance bond will cover the first year of support services. The surety must be a substantial surety company and authorized by law to conduct business in the state of domicile for the Customer, and endorsed by a local representative of such surety. The performance bond shall become effective upon execution of this Agreement and shall be provided by Manatron to Customer prior to the commencement of any work pursuant to this Agreement.


2. All other Provisions of the Agreement not amended, replaced, or deleted by this Amendment shall remain in full force and effect.






