

**AMENDMENT NO. 1 TO
SERVICES AGREEMENT
WITH NEW MEXICO FIRE SUPPORT SERVICES
TO PROVIDE DATA COLLECTION AND
ELECTRONIC RECORDS MANAGEMENT SERVICES**

THIS AMENDMENT is made and entered into as of the 14th day of March, 2012, by and between Santa Fe County, herein after "County," and New Mexico Fires Support Services, LLC, a New Mexico limited liability company, with a principal address located at 13170 Central SE, Suite B149, Albuquerque, NM 87123, hereinafter referred to as "the Contractor."

WHEREAS, pursuant to NMSA 1978, Section 13-1-112 and 13-117, competitive, sealed proposals were solicited via a formal request for proposals, RFP No. 2011-0004-FD/MS, for the provision of the services; and

WHEREAS, based on the evaluation criteria established within the request for proposals for the purposes of determining the most qualified Offeror, the County has determined Contractor as the most responsive and highest rated Offeror; and

WHEREAS, the County desires to engage the Contract to render data collection and electronic records management services described in the RFP, and the Contractor is willing to render such services; and

WHEREAS, the County requires these services and the Contractor is willing to provide these services and both parties wish to enter into this Agreement; and

WHEREAS, the parties wish to amend the Agreement under Section 17. "NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED," to increase the compensation in the amount of \$22,470.00.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

1. Paragraph 2.A. of Agreement 2011-0004-FD/MS is deleted in its entirety and replaced with the following:

A. In consideration of its obligations under this Agreement the Contractor shall be compensated as follows:

In no event shall the total compensation paid to Contractor by the County under this Agreement exceed One Hundred Twenty Thousand, Four Hundred Seventy Dollars (\$120,470.00) inclusive of gross receipts tax.


The County shall pay Contractor \$22.00 per hour (exclusive of gross receipts tax) Monday through Friday up to 40 hours per week and \$33.00 per hour (exclusive

of gross receipts tax) for any work performed Monday through Friday in excess of 40 hours and for any work performed on Saturday or Sunday. Any work performed that would qualify at a rate of \$33.00 per hour must be pre-approved by the County. Any work performed at the rate of \$33.00 per hour without the County's written pre-approval shall be paid at \$22.00 per hour.

2. All other provisions of Agreement No. 2011-0004-FD/MS not amended or replaced by this Amendment No.1 remain in full force and effect.






