

**AMENDMENT NO. 1
TO AGREEMENT WITH
ANAYA'S TOWING SERVICES
FOR EMERGENCY WRECKER AND TOWING
SERVICES FOR SANTA FE COUNTY DWI SEIZURE LOT**

THIS AMENDMENT is made and entered into as of the 19th day of March, 2012, by and between **Santa Fe County**, herein after "County" and **Anaya's Roadrunner Wrecker Services**, principal address at 2253 Ben Lane, Santa Fe, NM 87507, hereinafter referred to as "Contractor".

WHEREAS, pursuant to RFP No. 29-0017-SD/MS, on June 2, 2009, the County entered into Agreement 29-0017-SD/MS with Contractor to provide emergency wrecker and towing services for the County's DWI seizure lot;

WHEREAS, under Agreement No. 29-0017-SD/MS, the compensation/fee to be paid to Contractor is based on statewide wrecker tariff issued by the New Mexico Public Regulation Commission (PRC) dated August 27, 2000;

WHEREAS, the PRC has issued a revised wrecker tariff dated July 14, 2011;

WHEREAS, pursuant to Paragraph 18 of Agreement No. 29-0017-SD/MS, the Agreement may be amended by an instrument in writing executed by the parties and Paragraph 3.A states "[a]ny fee increases will be subject to the New Mexico Public Regulation Commission Wrecker Tariff;"

WHEREAS, the parties wish to amend the Agreement to make the compensation consistent with the revised PRC wrecker tariff dated July 14, 2011, **with prices becoming effective the date of the executed Amendment 1**, and increase the compensation in the amount of \$50,000 for services rendered through the term of the Agreement.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

1. Paragraph 3.A. of Contract 29-0017-SD/MS is deleted in its entirety and replaced with the following:

A. The total compensation to be paid under this Agreement including fees and costs, exclusive of gross receipts tax shall not exceed \$75,000.

The rates for towing services are in accordance with the New Mexico Public Regulation Commission statewide wrecker tariff, dated July 14, 2011.

*** Retrieval/Winching Rates include the following steps:


1. Hooking up the vehicle;
2. Winching the vehicle to the new position;
3. Unhooking from the vehicle;
4. Moving the wrecker to a new position; and
5. Re-hooking to the vehicle for loading.

Any fee increases will be subject to the New Mexico Public Regulation Commission Wrecker Tariff.


2. All other provisions of Agreement No. 29-0017-SD/MS not amended or replaced by this Amendment No.1 remain in full force and effect.


