

**AMENDMENT NO 1  
TO SANTA FE COUNTY PRICE AGREEMENT  
ON ROAD STRIPPING SERVICES**

**THIS AMENDMENT** is made and entered into as of this 5th day of June, 2013, by and between **Santa Fe County**, a political subdivision of the State of New Mexico (hereinafter referred to as the “ the County”) and **Highway Supply LLC.**, a Limited Liability Corporation with its principal place of business located at 6621 Chappell Road NE, Albuquerque, New Mexico 87113, hereinafter referred to as “Contractor”.

**WHEREAS**, in 2012 Santa Fe County and Contractor entered into Price Agreement No. 2012-0176-B-PW/MS for the Contractor’s provision of road stripping services;

**WHEREAS**, Article 5 of Agreement No. 2012-0176-B-PW/MS provides that the County may renew the Price Agreement for an additional one (1) year term;

**WHEREAS**, the term of Agreement No. 2012-0176-B-PW/MS expires May 24, 2013 and the parties wish to extend the term for one (1) additional year to May 24, 2014;

**WHEREAS**, Article 8 of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties; and


**WHEREAS**, by this Amendment No. 1 the term of Agreement No. 2012-0176-B-PW/MS will be extended to May 24, 2014.

**NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:**

1. A new subparagraph “A” is inserted in Article 5 Term to read as follows:
  - A. By Amendment No. 1 to this Agreement and the parties’ exercise of their option to extend the Agreement, the term of this Agreement is extended one (1) year. By Amendment No. 1, this Agreement shall, upon due execution by the parties, terminate on May 24, 2014, unless earlier terminated pursuant to paragraph 7 TERMINATION of this Agreement.
2. All other provisions of Price Agreement No.2012-0176-B-PW/MS not specifically amended or modified by this Amendment No.1, remain in full force and effect.






