

**SANTA FE COUNTY
AMENDMENT NO. 1 TO THE AGREEMENT
WITH SOUTHWEST HAZARD CONTROL, INC.
TO PROVIDE ON-CALL REMEDIATION SERVICES**

THIS AMENDMENT is made and entered into this 14th day of November 2014, by and between **Santa Fe County**, hereinafter referred to as “the County”, a New Mexico political subdivision, and **Southwest Hazard Control, Inc.** hereafter referred to as “the Contractor.”

WHEREAS, in accordance with Section 13-1-112 NMSA 1978, the County issued Request for Proposals (RFP) No. 2014-0015-PW/PL for on-call remediation services for hazardous conditions at County facilities;

WHEREAS, on November 26, 2013 the County and Contractor entered into Agreement No. 2014-0015A-PW/PL to provide these services for a term of one (1) year;

WHEREAS, Article 16, “NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED,” of Agreement No. 2014-0015A-PW/PL allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto; and


WHEREAS, the parties desire to enter into this Amendment No. 1 to extend the term for another year to November 26, 2015.

NOW THEREFORE, both parties agree as follows:

1. ARTICLE 5. “EFFECTIVE DATE AND TERM” a new subparagraph “5.a” is inserted to read as follow:
 - a. By Amendment No. 1, the County notifies Contractor and exercises the County’s option to extend the term of this Agreement for one (1) year from November 26, 2014 to November 26, 2015 on the same terms and conditions as stated in Agreement No. 2014-0015A-PW/PL.
2. All other provisions of Agreement No. 2014-0015A-PW/PL not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.


