**AMENDMENT NO. 1
TO MEMORANDUM OF AGREEMENT
BETWEEN SANTA FE COUNTY AND
THE SANTA FE PUBLIC SCHOOL DISTRICT
FOR TURQUOISE TRAIL CHARTER SCHOOL**

THIS AMENDMENT is made and entered into as of this 14th day of March, 2012 by and between **Santa Fe County**, a political subdivision of the State of New Mexico (hereinafter referred to as "the County") and the **Santa Fe Public School Board** (hereinafter referred to as "SFPS").

WHEREAS, on June 7, 2011 the County and SFPS entered into a Memorandum of Agreement to provide for the parties' agreement on the County's compensation of SFPS for cost increases incurred by SFPS in the construction of a 12" waterline, rather than an 8" waterline to serve the Turquoise Trail Charter School;

WHEREAS, the compensation in the form of credit based on actual construction costs of certain items upon the completion of the waterline and its conveyance to the County was based on Exhibit A that was attached to the Agreement;

WHEREAS, the construction of the waterline by SFPS is complete and the final credit amount will be determined based on the actual costs incurred by SFPS in constructing the items set forth on Exhibit A;

WHEREAS, in attempting to determine the credit amount upon completion of construction it was discovered that certain items were inadvertently omitted from Exhibit A to the Agreement;

WHEREAS, Article 8 of the Agreement allows the parties to amend the Agreement by an instrument in writing;

WHEREAS, the parties wish to amend the Agreement to replace Exhibit A with a more thorough and accurate Exhibit A.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1. Article 2 (Compensation) of the Agreement is amended by replacing in its entirety "Exhibit A" referred to in Paragraph 2 and replacing it with the Exhibit A attached hereto.
3. All other provisions of the Memorandum of Agreement not specifically amended as stated in this Amendment No. 1, remain in full force and effect.
