

**AMENDMENT NO. 2 TO  
PROFESSIONAL SERVICES AGREEMENT  
BETWEEN SANTA FE COUNTY AND  
HEALTHFRONT, P.C.**

**THIS AMENDMENT** is made and entered into as of this 29<sup>th</sup> day of July, 2013, by and between **Santa Fe County**, a political subdivision of the State of New Mexico (hereinafter referred to as the "County"), and **Healthfront, P.C.**, located at 1640 Old Pecos Trail, Suite H, Santa Fe, NM 87595 (hereinafter referred to as the "Contractor").

**WHEREAS**, on August 11, 2009, the County entered into Agreement No. 2010-0020-CORR/MS with the Contractor for the Contractor to provide Medical Director Services for the Santa Fe County Corrections Department for a term of four (4) years for a not-to-exceed sum of \$1,092,000.00 over the life of the Agreement;

**WHEREAS**, according to Article 18 of Agreement No. 2010-0020-CORR/MS, the parties may amend the Agreement by an instrument in writing executed by the parties;

**WHEREAS**, by Amendment No. 1 dated March 26, 2010 Agreement No. 2010-0020-CORR/MS was amended to change the Contractor name from "Northern New Mexico Emergency Medical Services, P.C." to "Health Front P.C.";

**WHEREAS**, these services are currently undergoing a competitive bidding process which will not be completed until after the expiration date of this Agreement August 11, 2013;

**WHEREAS**, the County needs a continuation of medical services provided by this Contractor and a lapse in services should not be allowed to occur, therefore this Agreement needs to be extended until the competitive bidding process is completed;

**WHEREAS**, the parties are in agreement to extend Agreement No. 2010-0020-CORR/MS until November 11, 2013 and increase the Contractor's monthly compensation from \$22,750.00 per month to \$28,438.00 per month;

**WHEREAS**, with this Amendment No.2, the total compensation payable under this Agreement is \$1,177,314.00

**NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:**

- I. Article 3 A. "Compensation and Invoicing", insert a new paragraph "A(i)" to read as follows:
  - (i) By Amendment No. 2 to extend the term of this Agreement, the monthly compensation paid to the Contractor from August 11, 2013 to November 11, 2013 is increased by \$5,688.00 per month. From August 11, 2013 to November 11, 2013,

compensation shall be paid to the Contractor in an amount not-to-exceed \$28,438.00 per month.

2. Article 4 "Effective Date and Term" insert a new subparagraph "A" to read as follows:


A. By Amendment No. 2, the term of this Agreement is extended from August 11, 2013, to November 11, 2013, unless earlier terminated pursuant to Article 5 "Termination" or Article 12 "Appropriations and Authorizations";

3. All other provisions of Agreement No. 2010-0020-CORR/MIS not specifically amended or modified by Amendment No. 1 or this Amendment No. 2 shall remain in full force and effect.






