

**AMENDMENT NO. 2
TO SERVICES AGREEMENT BETWEEN SANTA FE COUNTY AND
PRESBYTERIAN HEALTH SERVICES
TO PROVIDE EMPLOYEE ASSISTANCE PROGRAM SERVICES**

THIS AMENDMENT is made and entered into on the 14th day of April, 2014, by and between **Santa Fe County** (hereinafter referred to as the "County") and **Presbyterian Healthcare Services**, with its principal place of business at **9521 San Mateo Blvd, NE, Albuquerque, New Mexico 87113** (hereinafter the "Contractor").

WHEREAS, the County and the Contractor entered into a Services Agreement No. 2013-0132-MG/MS on March 19, 2013;

WHEREAS, Article 15, "NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED," of the Services Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties:

WHEREAS, by Amendment No. 1, dated November 18, 2013, and pursuant to Paragraph 8 of the Agreement, the County approved the assignment of Services Agreement No. 2013-0132-MG/MS by the former contractor The Solutions Group to the present contractor Presbyterian Health Services. Presbyterian Health Services has been performing all the services and duties under Services Agreement No. 2013-0132-MG/MS;

WHEREAS, Article 3, "EFFECTIVE DATE AND TERM," of the Agreement allows the parties to extend the term on a year-to-year basis for three (3) additional years;

WHEREAS, the parties wish to exercise their option to extend the term for one (1) year and increase the compensation for the extended term to March 19, 2015.

NOW, THEREFORE, in consideration of the premises and mutual obligations herein, the parties mutually agree as follows:

1. Article 2.A.2), "COMPENSATION, INVOICING, AND SET-OFF," subparagraph A.2) is amended by inserting a subparagraph "a" to read as follows:
 - a. Pursuant to Amendment No. 2 to this Agreement, the compensation payable to the Contractor for the term of March 19, 2014 to March 19, 2015 shall not exceed Thirty-Five Thousand Dollars and No Cents (\$35,000.00), exclusive of NM GRT. The total amount payable to the Contractor under this Agreement as amended shall not exceed Seventy Thousand Dollars and No Cents (\$70,000.00).

2. Article 3, "EFFECTIVE DATE AND TERM," a subparagraph "A" is inserted to read as follows:

A. By this Amendment No. 1, the parties agree to extend the term of this Agreement for one (1) year. This first term extension shall commence March 19, 2014 and terminate March 19, 2015.

3. All other provisions of Services Agreement No. 2013-0132-MG/MS not amended, replaced, or superseded by Amendment No. 1 or this Amendment No. 2 shall remain in full force and effect.
