

**AMENDMENT NO. 2
TO PROFESSIONAL SERVICES AGREEMENT
WITH FIRESTIK STUDIO**

THIS AMENDMENT is made and entered into this 7th day of January, 2020 between **Santa Fe County**, hereinafter the “County”, and **Firestik Studio**, hereinafter “Contractor.”

WHEREAS, on January 8, 2018, the County and the Contractor entered into Agreement No. 2018-0170-PW/MAM (Agreement) for the Contractor’s provision of graphic design and advertising services for the Sustainability Office of the County Public Works Department; and

WHEREAS, Article 4 (Effective Date and Term) of the Agreement provides for the option to extend the term of the Agreement; and

WHEREAS, Article 15 (No Oral Modifications; Written Amendments Required) of the Agreement allows the parties to amend the Agreement by an instrument in writing signed by the parties; and

WHEREAS, Amendment No. 1 extended the term of the Agreement to January 8, 2020. By this Amendment No. 2 the parties agree to extend the term of the Agreement for one year and increase the compensation payable to the Contractor by the sum of \$18,750.00.

NOW THEREFORE, the parties agree to amend the Agreement as follows:

1. Article 1 (Scope of Work) is amended by inserting a subpart E to read:
 - E. By Amendment No. 2 to this Agreement, Contractor will continue to perform tasks pertaining to the County’s Outreach Information Campaign. Tasks to be completed include without limitation:
 - a) Digital ads,
 - b) Print media ads,
 - c) Brochures,
 - d) Website graphics,
 - e) Maps,
 - f) Bus wraps
 - g) Table banner, and
 - h) Stand-up displays.

2. Article 3.A.1) is amended by inserting a subpart (a) to read:
 - (a) By Amendment No. 2 to this Agreement and for the on-call design and production services described in 1.E above, the Contractor shall be compensated \$18,750.00 at the hourly rate of \$125.00.

3. Article 3.A.2) is amended by inserting a subpart (a) to read:

(a) By Amendment No. 2 to this Agreement, the total amount payable to the Contractor is increased by the sum of \$18,750.00. For the term of this Agreement the total amount payable to the Contractor shall not exceed \$68,750.00, exclusive of NM grt.

4. Article 4 (Effective Date and Term) is amended by inserting a subparagraph b to read:

b. By Amendment No. 2 to this Agreement, the term of this Agreement is extended from January 8, 2020 to January 8, 2021.

5. All other provisions of the Agreement not specifically amended or modified by Amendment No. 1 and this Amendment No. 2 shall remain in full force and effect.

**AMENDMENT NO. 2
TO PROFESSIONAL SERVICES AGREEMENT
WITH FIRESTIK STUDIO**

THIS AMENDMENT is made and entered into this ____ day of _____, 20__ between Santa Fe County, hereinafter the "County", and Firestik Studio, hereinafter "Contractor."

WHEREAS, on January 8, 2018, the County and the Contractor entered into Agreement No. 2018-0170-PW/MAM (Agreement) for the Contractor's provision of graphic design and advertising services for the Sustainability Office of the County Public Works Department; and

WHEREAS, Article 4 (Effective Date and Term) of the Agreement provides for the option to extend the term of the Agreement; and

WHEREAS, Article 15 (No Oral Modifications; Written Amendments Required) of the Agreement allows the parties to amend the Agreement by an instrument in writing signed by the parties; and

WHEREAS, Amendment No. 1 extended the term of the Agreement to January 8, 2020. By this Amendment No. 2 the parties agree to extend the term of the Agreement for one year and increase the compensation payable to the Contractor by the sum of \$18,750.00.

NOW THEREFORE, the parties agree to amend the Agreement as follows:

1. Article 1 (Scope of Work) is amended by inserting a subpart E to read:

E. By Amendment No. 2 to this Agreement, Contractor will continue to perform tasks pertaining to the County's Outreach Information Campaign. Tasks to be completed include without limitation:

- a) Digital ads,
- b) Print media ads,
- c) Brochures,
- d) Website graphics,
- e) Maps,
- f) Bus wraps
- g) Table banner, and
- h) Stand-up displays.

2. Article 3.A.1) is amended by inserting a subpart (a) to read:

(a) By Amendment No. 2 to this Agreement and for the on-call design and production services described in 1.E above, the Contractor shall be compensated \$18,750.00 at the hourly rate of \$125.00.


3. Article 3.A.2) is amended by inserting a subpart (a) to read:

(a) By Amendment No. 2 to this Agreement, the total amount payable to the Contractor is increased by the sum of \$18,750.00. For the term of this Agreement the total amount payable to the Contractor shall not exceed \$68,750.00, exclusive of NM grt.
4. Article 4 (Effective Date and Term) is amended by inserting a subparagraph b to read:

b. By Amendment No. 2 to this Agreement, the term of this Agreement is extended from January 8, 2020 to January 8, 2021.
5. All other provisions of the Agreement not specifically amended or modified by Amendment No. 1 and this Amendment No. 2 shall remain in full force and effect.
