

Amendment No. 2 to PSA 2011-0123-CSD/TRV

Amendment No. 2 to
Professional Services Agreement No. 2011-0123-CSD/TRV
Between Santa Fe County and IMPACT Personal Safety

THIS AMENDMENT is made and entered into this 21 day of June, 2012 by and between Santa Fe County, hereinafter the "County," and **IMPACT Personal Safety**, a New Mexico non-profit organization with a principle address at P.O. Box 8350, Santa Fe, NM 87504, hereinafter the "Contractor."

WHEREAS, pursuant to NMSA 1978, §13-1-125 (small purchase), the County entered into a two-year Professional Services Agreement No. 2011-0123-CSD/TRV on December 1, 2010 with Contractor for the provision of anger management classes for participants of the County's Teen Court;

WHEREAS, by Amendment No. 1 dated June 24, 2011 the parties amended the Agreement to increase the compensation by \$7,497.00 and to provide for continuation of services by the Contractor through FY 2012 resulting in a contract value of \$11,997.00;

WHEREAS, by this Amendment No. 2 the parties desire to amend the Agreement to increase the compensation by \$3,213.00 and continue the Contractor's services into FY 2013 through December 1, 2012 when the Agreement expires;

WHEREAS, Paragraph 17 of the Agreement allows the parties to amend the agreement through a written amendment.

NOW THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

1. Article 2, paragraph A of Agreement No. 2011-0123-CSD/TRV as amended by Amendment No. 1, is amended to insert a subparagraph A(1) to read as follows:

(1) From July 1, 2012 to December 1, 2012 the County shall pay Contractor a sum not-to-exceed \$3,213.00, exclusive of gross receipts tax. This compensation is based on the following rates and classes to be performed for 3 groups from Teen Court:

Personal Safety Class	\$130.00/ 60 minute session (\$130 X 3 = \$390.00)
The Roots of Violence	\$141.00/60 minute session (\$141 X 3 = \$423.00)
Verbal Experiential Class	\$800.00 /3 hr session (\$800 X 3 = \$2,400.00)

2. All other provisions of Agreement No. 2011-0123-CSD/TRV not amended or replaced by Amendment No. 1 and this Amendment No. 2 shall remain in full force and effect.




