

**AMENDMENT NO. 3  
TO PSA BETWEEN SANTA FE COUNTY  
AND PEREGRINE CORPORATION**

**THIS AMENDMENT** is made and entered into as of this 25<sup>th</sup> day of August, 2015 by and between **Santa Fe County**, hereinafter referred to as "the County", a New Mexico political subdivision, and **Peregrine Corporation**, hereinafter referred to as "the Contractor".

**WHEREAS**, on October 12, 2012, the County and the Contractor entered into Agreement No. 2013-0126-AS/MS (Agreement) for the Contractor's provision of printing and mailing of NOV's and business personal property declarations services; and

**WHEREAS**, Article 3 (Effective Date and Term) of the Agreements provides for a one-year term for the initial term of the Agreement and reserves to the County the option to extend the term of the Agreement in one-year increments; and

**WHEREAS**, Amendment Nos. 1 and 2 increased the Agreement compensation by \$60,000.00 and extended the term to October 12, 2015; and

**WHEREAS**, by this Amendment No. 3 the County wishes to extend the term of the Agreement for one year and increase the Contractor's compensation by \$60,000.00

**NOW, THEREFORE**, the parties agree as follows:

1. Article 2.A.1) (Compensation, Invoicing, and Set-Off) is amended by inserting a new subparagraph "c" to read as follows:

c) By Amendment No. 3, the term of this Agreement is extended by one year. The amount of compensation payable to the Contractor for the term of October 12, 2015 to October 12, 2016 shall not exceed Sixty Thousand Dollars and No Cents (\$60,000.00), exclusive of NM grt and in accordance with Appendix A. The total amount payable to the Contractor under this Agreement as amended shall not exceed Two Hundred Forty Thousand Dollars, (\$240,000.00), exclusive of NM gross receipts tax.

2. Article 3 (Effective Date and Term) is amended by deleting the second sentence in its entirety and replace with the following: The County has the option to extend the term of this Agreement in one-year increments and on the same terms and conditions stated herein, for three additional years not to exceed a total of four years.

3. Article 3 (Effective Date and Term) is amended by inserting a new subpart C to read as follows;

C. By Amendment No. 3, the term of this Agreement is extended for one year from October 12, 2015 to October 12, 2016.

4 All other provisions of Agreement No. 2013-0126-AS/MS not specifically amended or modified by Amendment Nos. 1 and 2 and this Amendment No. 3 shall remain in full force and effect.




