

**AMENDMENT NO. 11
TO THE AGREEMENT BETWEEN SANTA FE COUNTY
AND TERRI WERNER**

THIS AMENDMENT is entered into this 11th day of August 2026, between Santa Fe County (the "County") and Terri Werner (the "Contractor").

WHEREAS, the County and Contractor entered into Agreement No. 2018-0282-CSD/KE (the "Agreement") on August 3, 2018, to provide for the Contractor's provision of services as event coordinator for the County's Stanley Cyclone Center; and

WHEREAS, Article 15 (No Oral Modifications; Written Amendment required) of the Agreement allows the parties to amend the Agreement by a written amendment signed by the parties; and

WHEREAS, Amendment Nos. 1 through 10 extended the term and increased the compensation payable to the Contractor; and

WHEREAS, by this Amendment No. 11 the parties agree to amend the Agreement to extend the term for a final two years to 2028 as provided in NMSA 1978, Section 13-1-150 (A), and increase the compensation payable to the Contractor for FY 2027 and FY 2028; and

WHEREAS, the Procurement Manager determined pursuant to Section 50 (A) of the Santa Fe County Purchasing Regulations (Multi-term contracts, Determination Prior to Use), and NMSA 1978, Section 13-1-151 (Multi-term contracts; determination prior to use), that the requirements cover the period of the contract and are reasonably firm and continuing, and that the contract will serve the best interest of the County.

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Article 3.A.1 (Compensation, Invoicing and Set-off) insert a subparagraph i to read:

- i. By Amendment No. 11 the compensation payable to the Contractor is increased by the sum of \$150,000 for services performed by the Contractor in FY 2027, and FY 2028. The total amount payable to the Contractor for the term of this Agreement will not exceed \$749,000.00, *inclusive* of NM GRT.

2. Article 4 (Effective Date and Term) inserting a subparagraph h to read:

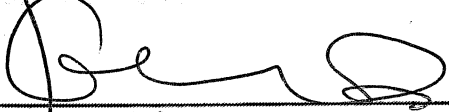
- h. By Amendment No. 11 the term is extended to August 3, 2028. By Amendment No. 11 this Agreement is a multi-term contract under Section 50 of the Santa Fe County Purchasing Regulations, and NMSA 1978, Section 13-1-150 (Multi-term contracts; specified period). Pursuant to Section 50 (D) of the

Purchasing Regulations, and NMSA 1978, Section 13-1-152 (Multi-term contracts; cancellation due to unavailability of funds), if funds are not appropriated or otherwise made available to support compensation payable to the Contractor for the 10th fiscal year (FY 2028), this Agreement will be cancelled.

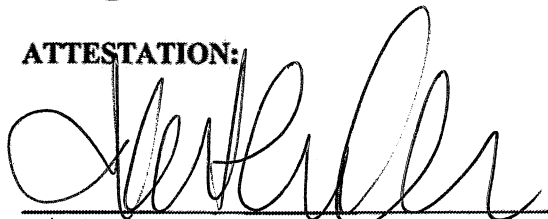
3. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1 through 10 and this Amendment No. 11 will remain in full force and effect.

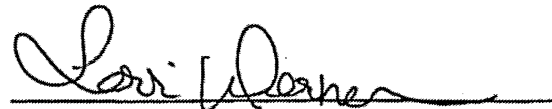
