Re: Letter from Parties in Case No. 24-5200 pursuant to Order Consolidating Appeals;  
Recognizing Parties with Standing; and Scheduling Pre-Hearing Special Meeting

Dear Mr. Sisneros and Mr. Prucino:

In addition to the above-mentioned letter that summarizes the items discussed on the Friday June 6<sup>th</sup>, 2025, meeting, demanded by the BCC, I have the following remarks:


1. The Planning Commission made its decision, and we have the right to appeal against that.
2. We, as opponents, had to pay \$200 to be eligible to be a party with standing. We had to write a letter of intent, explaining the grounds for our appeal. This needed to be done before a deadline.
3. We were told by Mr. Dominic Sisneros we were the only parties with standing and that only opponents have the right to appeal.
4. We were then forced into a meeting with AES and their proponents.
5. There it became clear the proponents were contacted by the County and offered standing, without paying the \$200 and without a letter of intent, all after the deadline, set by the County, was expired.
6. Obviously, the County provides contradicting information.
7. The SLDC does not mention a procedure for the way the BCC is going forward with the appeal process.
8. I fail to see the justification of offering proponents standing, basically taking time away from opponents who have regulated rights to be properly heard.

9. The proponents should have the same rights as the general public. They have had their time before the Planning Commission, and by now giving them standing, this appeal procedure against, is becoming a political showdown and reprise of the biased meeting before the Planning Commission.
10. I expect the \$200 filing fee will be returned to the opponents or charge to the proponents and that letters of intent will be produced by the proponents as well.

I would like to request that you provide this letter to the Board of County Commissioners together with the above-mentioned letter of the other parties.
