## MEMORANDUM OF UNDERSTANDING BETWEEN

## SANTA FE COUNTY AND THE AMERICAN FEDERATION OF STATE, COUNTY AND MUNICIPAL EMPLOYEES/LOCAL 1782

This Memorandum of Understanding ("MOU") is entered into by and between Santa Fe County ("County") and the American Federation of State, County, and Municipal Employees Local 1782 ("Union") (collectively, the "Parties") as of the date is signed by both Parties.

## **RECITALS**

**WHEREAS,** the County and the Union are parties to that certain Collective Bargaining Agreement with a term of June 25, 2013, through December 31, 2015; and

**WHEREAS**, the Parties have been in negotiations concerning a new Collective Bargaining Agreement and those negotiations are ongoing; and

WHEREAS, as part of those negotiations, the Parties have agreed upon a wage increase for bargaining unit members and desire to implement that wage increase before all other terms of the new Collective Bargaining Agreement have been agreed upon.

## **AGREEMENT**

**NOW, THEREFORE,** in consideration of the mutual covenants and obligations contained herein, and other good and valuable consideration, the receipt of which is hereby acknowledged, the Parties agree as follows:

- 1. Effective the pay period ending June 10, 2016, (i) bargaining unit employees with a base hourly rate of pay of less than \$24.0384 shall receive a 2% cost of living adjustment to their base hourly rate of pay and (ii) bargaining unit employees with a base hourly rate of pay of \$24.0384 or more shall receive a 1% cost of living adjustment to their base hourly rate of pay.
- 2. The pay increase provided in Section 1 of this Agreement shall be incorporated into Article 29, "Classification and Pay Plan", of the new Collective Bargaining Agreement. The Parties acknowledge and agree that Article 29 of the new Collective Bargaining Agreement may be the subject of further negotiations
