## RESOLUTION NO. 2020 <u>57</u>

## SANTA FE COUNTY, NEW MEXICO GENERAL OBLIGATION BOND ELECTION RESOLUTION

WHEREAS, the Board of County Commissioners (the "Board") of Santa Fe County, New Mexico (the "County"), has determined upon its own initiative to submit to an election the question of the issuance of its general obligation bonds in the maximum amounts and for the purposes hereinafter specified without the prior filing of a petition by qualified electors; and

WHEREAS, it is the opinion of the Board that it is necessary and in the best interests of the residents of the County that there be submitted to a vote of the registered qualified electors of the County, the questions of whether the County should issue its general obligation bonds for the purposes hereinafter specified; and

WHEREAS, it is the opinion of the Board that it is necessary and in the best interests of the residents of the County to provide (i) improvements and restoration to open space, trails and parks within the County, (ii) suitable and sufficient improvements to roads within the County, and (iii) County water and wastewater projects within the County.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SANTA FE COUNTY, NEW MEXICO AS FOLLOWS:

Section 1. The Board does hereby propose that the following questions be included on the ballot and submitted to the registered qualified electors of Santa Fe County, New Mexico, at the general election on Tuesday, November 3, 2020:

- A. Shall Santa Fe County issue up to \$4,829,000 in general obligation bonds payable from general (ad valorem) taxes to acquire, design, construct, improve, equip, and restore open space, trails and parks within the County?
- B. Shall Santa Fe County issue up to \$11,421,000 in general obligation bonds payable from general (ad valorem) taxes to acquire, construct, design, equip, and improve roads within the County?
- C. Shall Santa Fe County issue up to \$3,750,000 in general obligation bonds payable from general (ad valorem) taxes to acquire real property and necessary water rights for, and to construct, design, equip, rehabilitate, and improve, water and wastewater projects within the County?

Section 2. Pursuant to Section 1-16-3(B) NMSA 1978, this Resolution shall be filed with the County Clerk, who is hereby requested to certify each of the foregoing ballot questions to the Secretary of State not less than sixty-seven (67) days prior to November 3, 2020 (i.e. no later than August 28, 2020).
