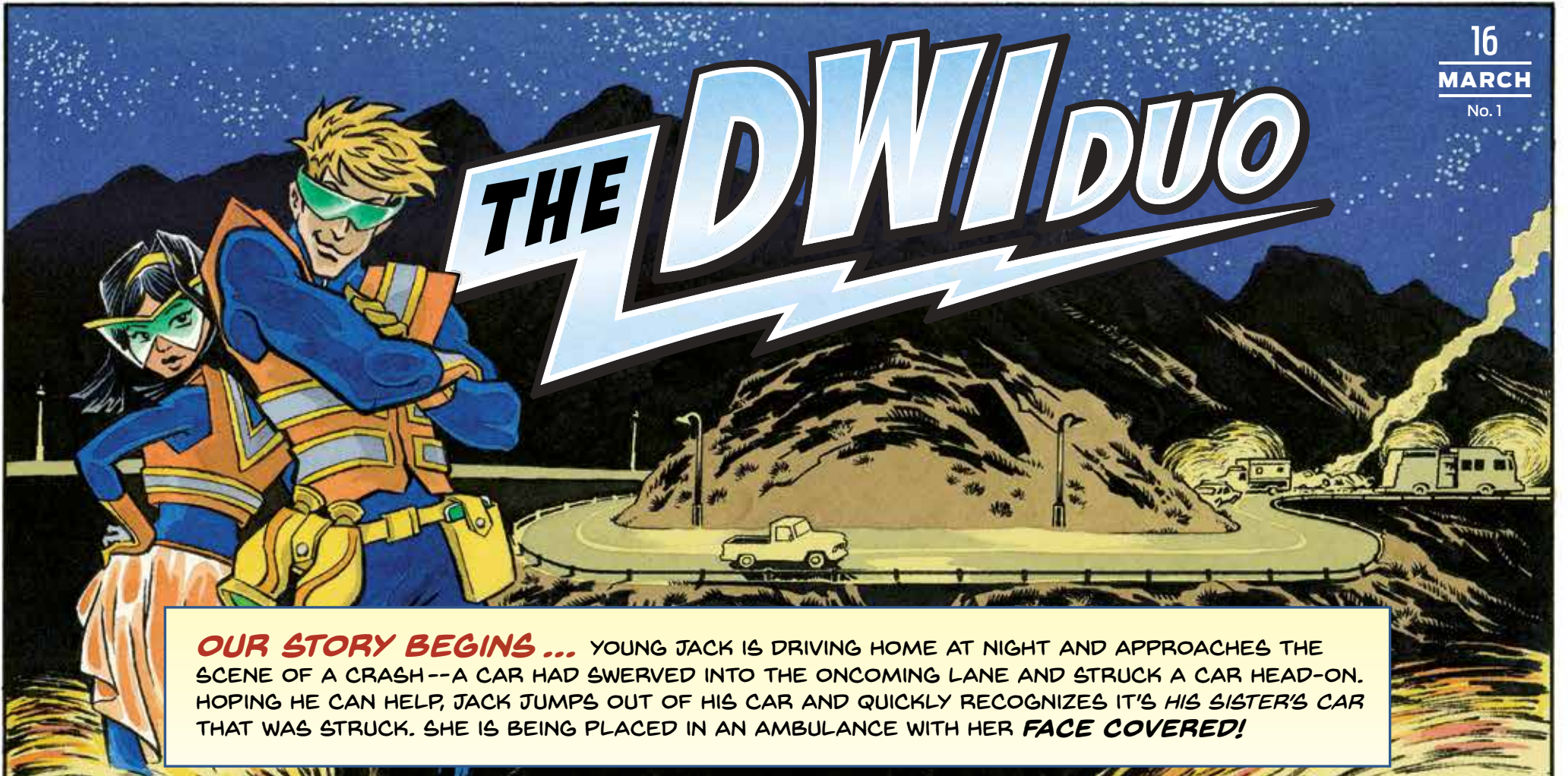


THE DWI DUO

Making the Call, Every Day

Targeting other substance abuse problems

As part of their sentence, drunk drivers convicted in Santa Fe County since August 2014 must call every day between 5am and 8am to find out if they must report to provide a urine sample to be tested for drugs and alcohol.

If there is any violation, a positive test for alcohol or illicit drugs, or not reporting, the court is informed and further sanctions may be imposed by the judge. Each offender is supervised by the Santa Fe County DWI Program staff to track and report compliance to the court.
