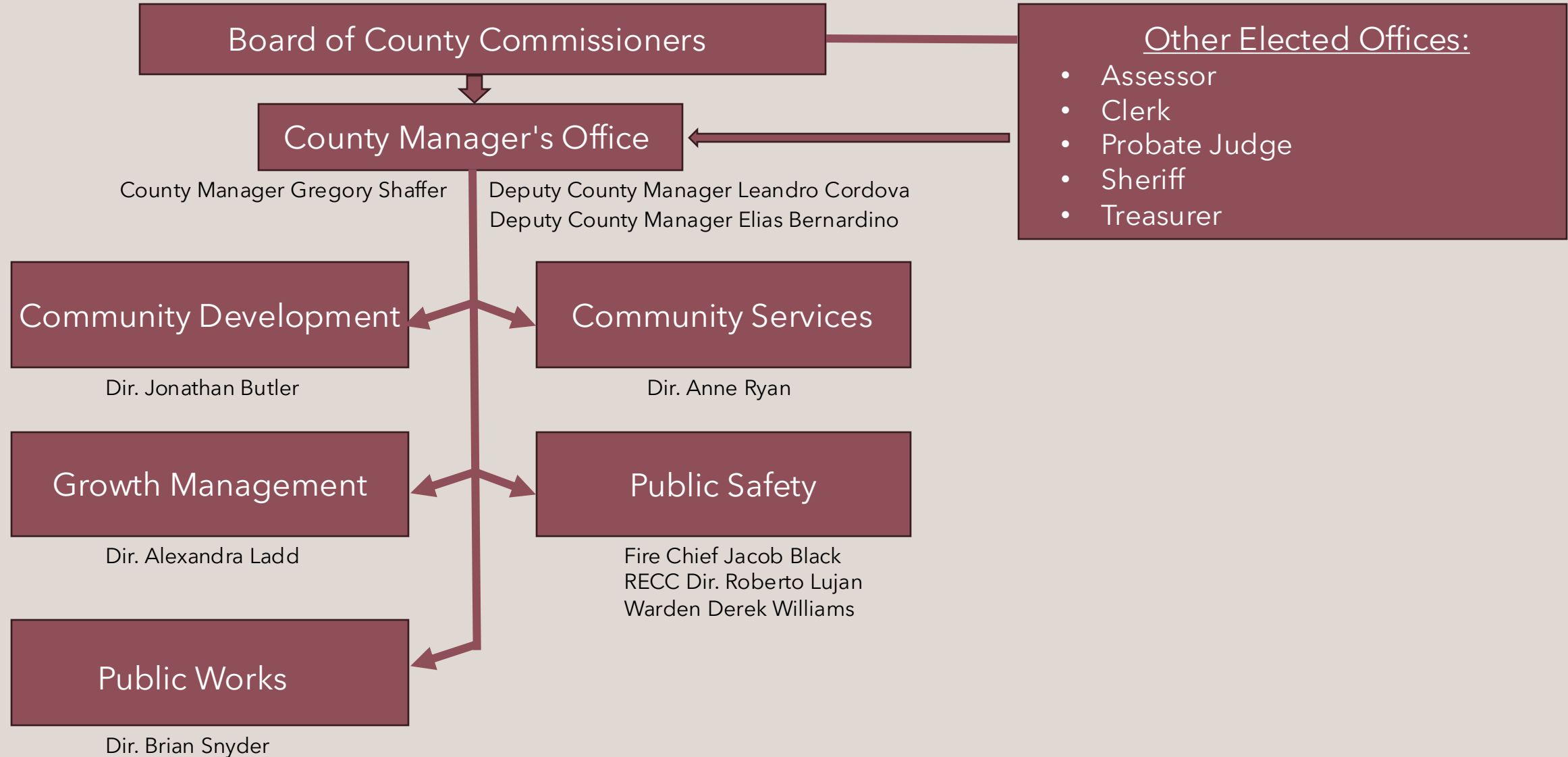

Staff Updates from June Feedback

- **CO/RO reports for Hearing Officer, Planning Commission, and BCC** > generally a week beforehand, with additional lead time for BCC
- **RO's at TAC?** > No, not currently. Only CO's will be permitted to attend the Pre-Application TAC when proposed projects are within their CO's geographic area
- **SGMP/Community Plan analysis for cases** > Planning staff have begun to review discretionary applications for consistency with the SGMP and relevant Community Plans.
- **Public Dashboard of Development Review Cases** > TBD, the new Building & Development Manager starts in early October.
- **Applicants will email CORO contacts** > Being incorporated into the development review procedures.
