### **Summary of Meeting**

#### **Welcome and Introductions**

The La Cienega/La Cieneguilla Planning Committee had their kickoff meeting on Tuesday, March 19<sup>th</sup> at the La Cienega Community Center. Approximately 32 community members attended along with the entire County Planning staff and three staff from the North Central Regional Transit District (NCRTD).

#### **Community Planning Policies**

Staff presented the process for community plans as outlined in [Chapter 2](#) of the Sustainable Land Development Code (SLDC). The process is visualized in the "Community Planning Process Flowchart" document. Next, Staff presented the various roles and responsibilities for County Staff and Planning Committee members (refer to the "Community Planning Roles & Responsibilities" document).

#### **Public Participation Plan**

As required by SLDC Section 2.1, Staff developed an initial Public Participation Plan for the La Cienega/La Cieneguilla Community Plan Update. At the preliminary Planning Committee meeting, staff and the initial Planning Committee members incorporated additional feedback. Staff presented the Public Participation Plan and encouraged meeting attendees to spread the word about future meetings. Please refer to the "LCLCPC Public Participation Plan" document.

## Work Plan and Schedule

Staff presented a working draft Work Plan and Schedule for monthly Planning Committee meetings. Staff will finalize a schedule for meeting topics and share with the community.

## Community Issues Breakouts

Staff gave attendees a list of initial key community issues and the 2015 Community Vision Statement. Staff instructed attendees to discuss, develop, and write-down additional issues and amendments to the Vision Statement for the rest of the meeting. The leading discussion questions included the following: What is your community vision? What community issues do you want to address? How would you like to change your zoning regulations?
